

RELEASE OF EASEMENT FOR ELECTRICAL LINES

THIS INDENTURE WITNESSETH: That Northern Indiana Public Service Company, an Indiana corporation, the holder of an easement for Electrical Lines executed by John Harder and Thelma Harder, husband and wife dated August 7, 19 36, recorded August 11, 19 36, in Book 282, Page 520, in the Recorder's Office of Lake County, Indiana, in consideration of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged does hereby REMISE, RELEASE AND FOREVER QUIT CLAIM to John and Thelma Harder and to their successors and assigns, all the right, title and interest acquired under the aforesaid easement for electrical lines, in, upon, along and over the premises situated in Lake County, Indiana, described as follows:

A strip of land containing .027 acres, more or less in the NE 1/4 of Section 19, Township 36 North, Range 9 West of the 2nd Principal Meridian being 10 feet wide, lying 5 feet each side of a center line and said center line produced, said center line being described as follows:

Beginning at a point 191 feet East of the West line of the E 1/2 NE 1/4 of Section 19 and 1035.7 feet North of the South line of the NE 1/4 of Section 19; thence North and parallel to the West line of the E 1/2 NE 1/4 of Section 19 a distance of 117.5 feet.

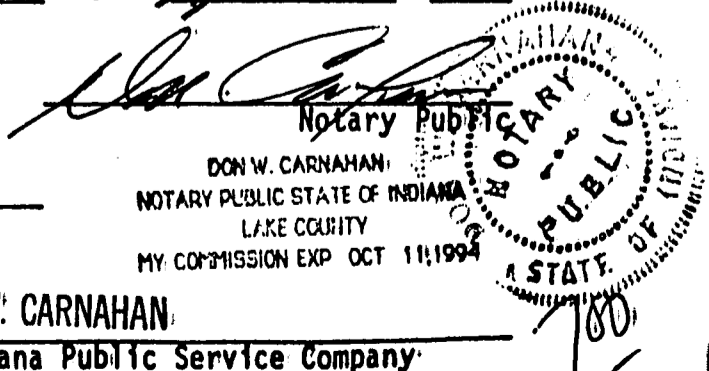
