

THIS INDENTURE WITNESSETH: That Northern Indiana Public Service Company, an Indiana corporation, the holder of an easement for Electrical Lines executed by John Dale Braund and Dorothy Elizabeth Braund, husband & wife dated December 23, 1935, recorded December 28, 1935, in Book 276, Page 7, in the Recorder's Office of Lake County, Indiana, in consideration of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged does hereby REMISE, RELEASE AND FOREVER QUIT CLAIM to John D. and Dorothy E. Braund and to their successors and assigns, all the right, title and interest acquired under the aforesaid easement for electrical lines, in, upon, along and over the premises situated in Lake County, Indiana, described as follows:

A strip of land containing .053 acres, more or less, in the NE 1/4 of Section 19, Township 36 North, Range 10 West of the 2nd Principal Meridian, being 10 feet wide, lying 5 feet each side of a center line and said center line produced, said center line being described as follows:

Beginning at a point 191 feet East of the center line of Greenwood Avenue on a produced line lying perpendicular to the center line of Greenwood Avenue at a point 580.54 feet North of the center line of Ridge Road; thence North and parallel to the center line of Greenwood Avenue, a distance of 229.52 feet. Number of poles, type of equipment and location thereof on this easement to be as outlined in letter dated 12-23-35.
