A part of the Southeast Quarter of the Southeast Quarter of Section 17, Township 36 North, Range 9 West, Lake County, Indiana, described as follows: Commencing at the southeast corner of said section; thence North 89 degrees 47 minutes 40 seconds West 382.41 feet along the south line of said section to the northeasterly boundary of U.S. 41; thence North 37 degrees 24 minutes 11 seconds West 771.76 feet along the boundary of said U.S. 41 thence South 88 degrees 18 minutes 33 seconds East 20.62 feet along said boundary; thence North 37 degrees 24 minutes 11 seconds West 90.00 feet along said thence North 34 degrees 21 minutes 01 second West 56.87 feet along said boundary to the thread of the stream of the Little Calumet River and the point of beginning of this description(which point of beginning is also described in Deed Record 1352, page 423, as being 144.56 feet north of the thread of the stream of the Little Calumet River): thence North 35 degrees 33 minutes 08 seconds West 168.45 feet along said boundary to the west corner of the owner's land; thence North 54 degrees 26 minutes 01 seconds East 38.91 feet along the northeastern line of the owner's land; thence South 37 degrees 24 minutes 11 seconds East 237.89 feet to the southwestern line of the owner's land; thence North 69 degrees 27 minutes 38 seconds West 83.51 feet to the point of beginning and containing 0.196 acres, more or less.
