states:

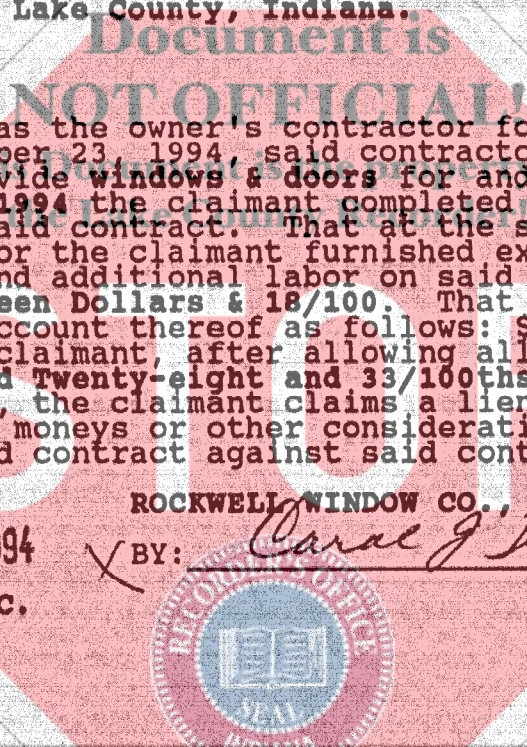
That on September 23, 1994, the owner owned the following described land in the County of LAKE, State of Indiana to wit:
