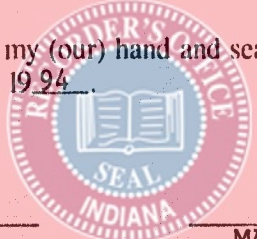

This power of attorney shall expire and terminate on DECEMBER 31, 1994.

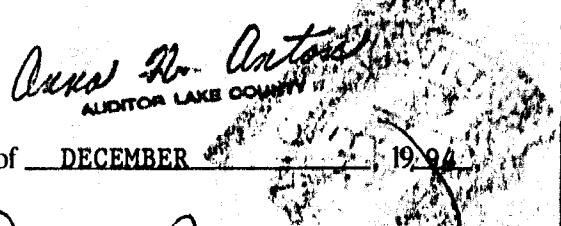
