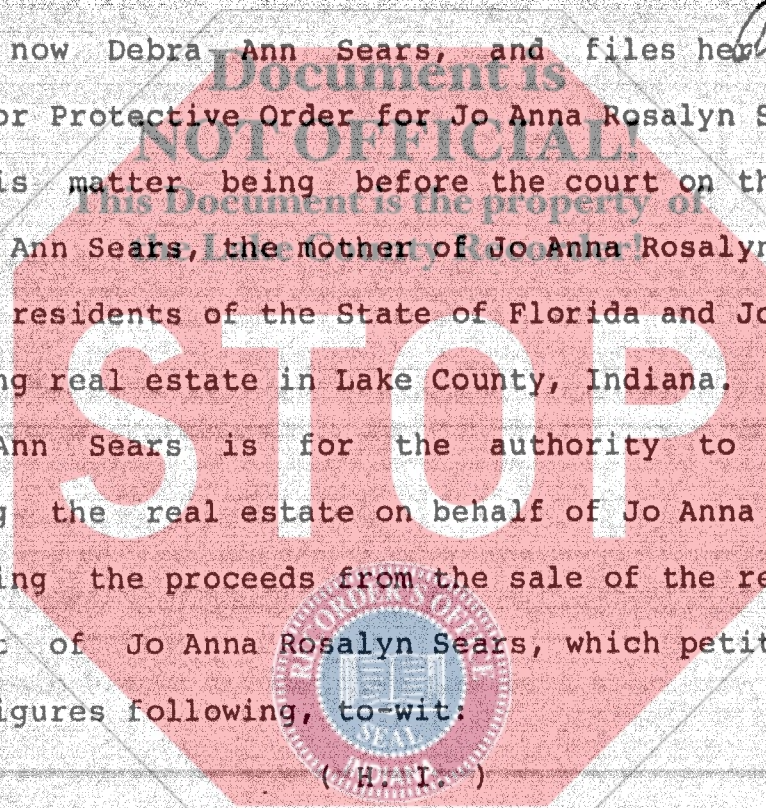
And the Court being duly advised in the premises now finds

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Debra Ann Sears, petitioner herein, be and is hereby authorized to execute a Deed on behalf of her minor child, Jo Anna Rosalyn Sears, and accept any and all proceeds from the sale of said real property.

That the Court directs that Debra Ann Sears pay any related expenses including an attorney's fee in the amount of two hundred dollars (\$200.00) and place the remaining funds in an interest bearing account located at American Savings Bank, Lake County, Indiana, in the name of Jo Anna Rosalyn Sears, solely, with the restriction that the funds be turned over to Jo Anna Rosalyn Sears upon her attaining the age of eighteen (18), or upon further order of this court, whichever is earlier. *Report to be filed*
