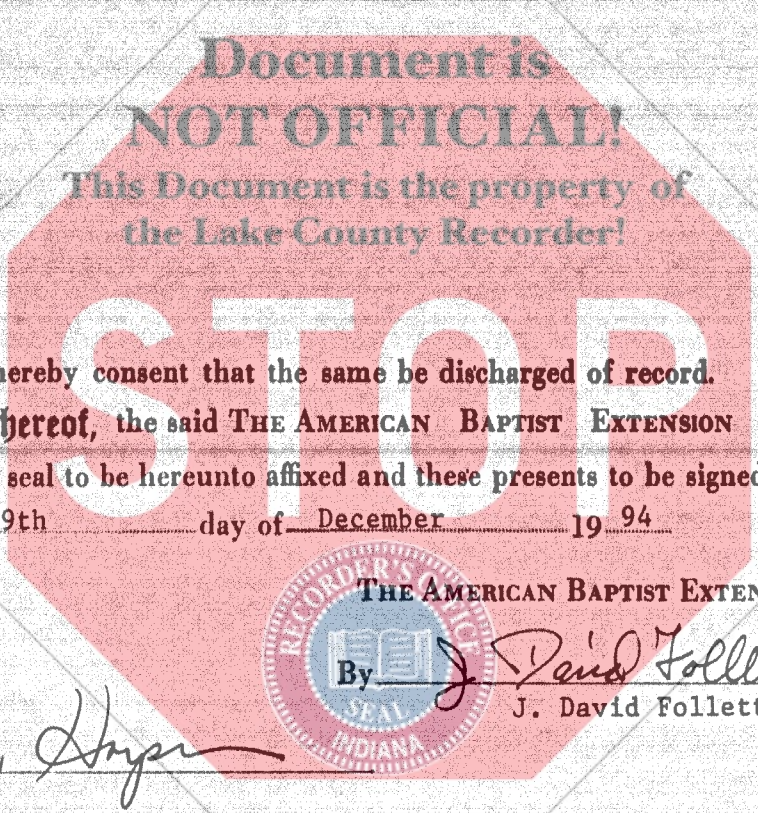

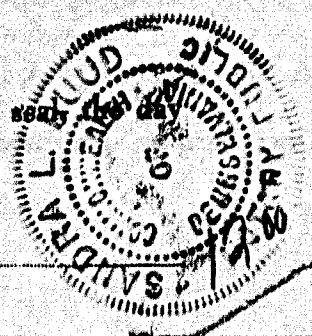


EXHIBIT "A"

Parcel 1: A part of the West 186.1 feet of the Southwest 1/4 of Section 19, Township 36 North, Range 9 West of the Second Principal Meridian in the Town of Munster, Lake County, Indiana described as beginning at a point in the West line of said Section 19, 1177.01 feet Northerly of the Southwest corner of said Section 19, measured along said West line; thence continuing Northerly on said West line 200 feet to a line that is parallel to and 622.58 feet Southerly of the South line of Calumet View Addition to Munster, as recorded in Plat Book 18 page 25 in the Recorder's Office, Lake County, Indiana; thence Easterly on a line parallel to and 622.58 feet Southerly of the South line of said Calumet View Addition to Munster, 186.1 feet to a point that is 1371.29 feet Northerly of the South line of said Section 19; measured along the line that is 186.1 feet East of the West line of said Section 19; thence Southerly on said 186.1 foot parallel line, 200 feet; thence Westerly 186.1 feet to the point of beginning excepting the West 40 feet taken for the opening and widening of Calumet Avenue.

Parcel 11: A part of the West 186.1 feet of the Southwest 1/4 of Section 19, Township 36 North, Range 9 West of the Second Principal Meridian, in the Town of Munster, Lake County, Indiana, described as beginning at a point in the West line of said Section 19, 1377.01 feet Northerly of the Southwest corner of said Section 19, measured along said West line; thence continuing Northerly on said West line 300 feet to a line that is parallel to and 322.58 feet Southerly of the South line of Calumet View Addition to Munster, as recorded in Plat Book 18, page 25 in the Recorder's Office Lake County, Indiana; thence Easterly on a line parallel to and 322.58 feet Southerly of the South line of said Calumet View Addition to Munster, 186.1 feet to a point that is 1671.29 feet Northerly of the South line of said Section 19; measured along the line that is 186.1 feet East of the West line of said Section 19; thence Southerly on said 186.1 foot parallel line, 300 feet; thence Westerly 186.1 feet to the point of beginning, excepting the West 40 feet taken for the opening and widening of Calumet Avenue.
