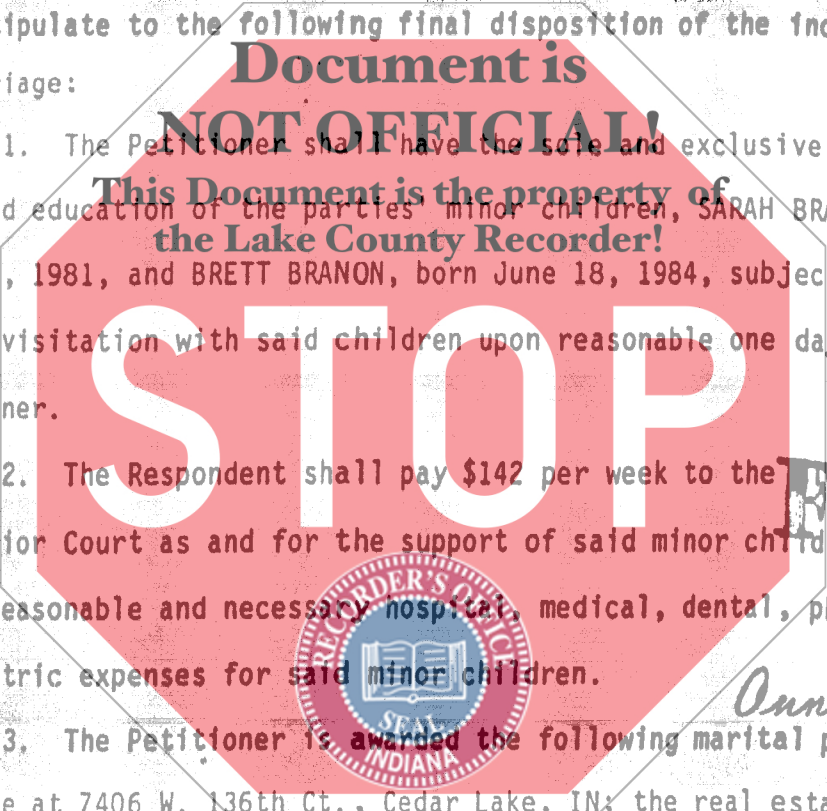

a satisfactory division of all furniture, appliances, vehicles, accounts and all other items of tangible and intangible personal property.

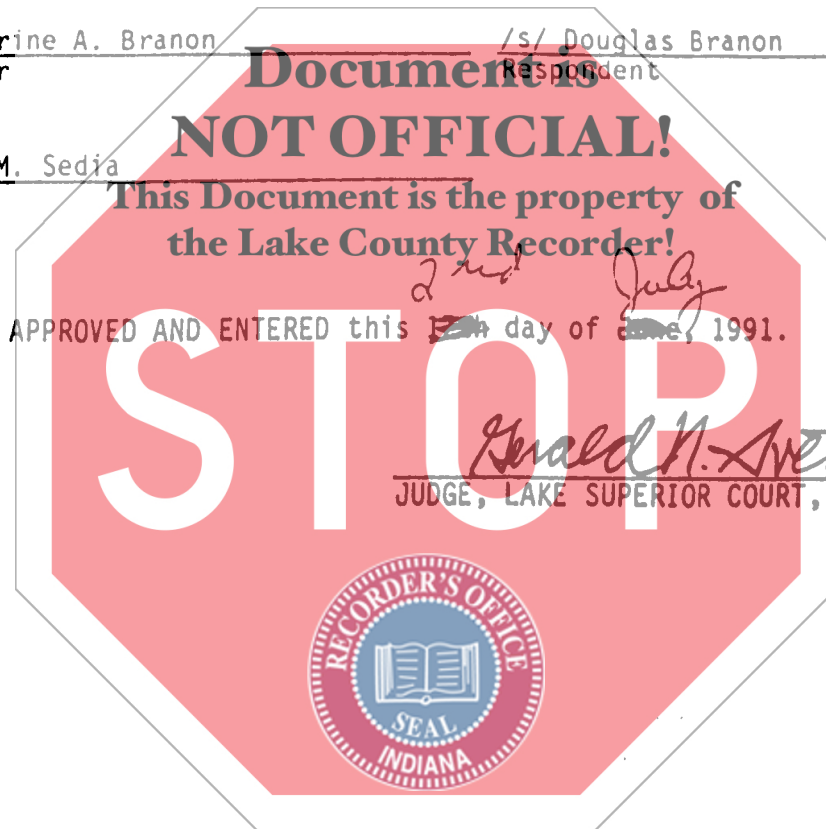
