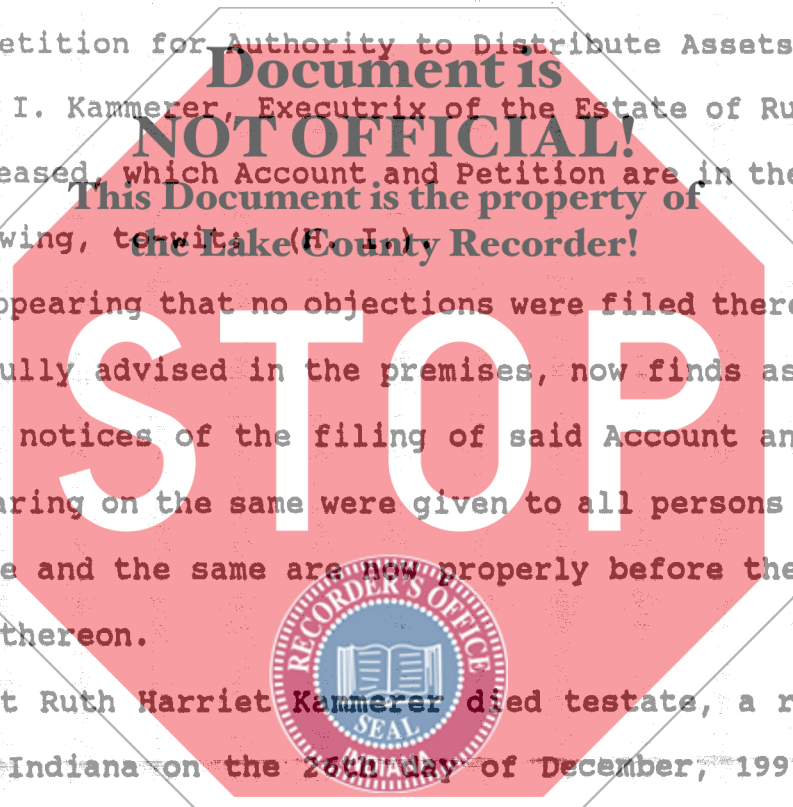

3. The matters and things stated in said Account and Petition are true and said Executrix has accounted for all the assets in said estate coming into her hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent. No claims were filed against said estate and all bills of said estate have been paid and discharged. Neither said decedent nor her Executrix was an employer of labor within the meaning of that term as used in the Indiana Employment Security Act. 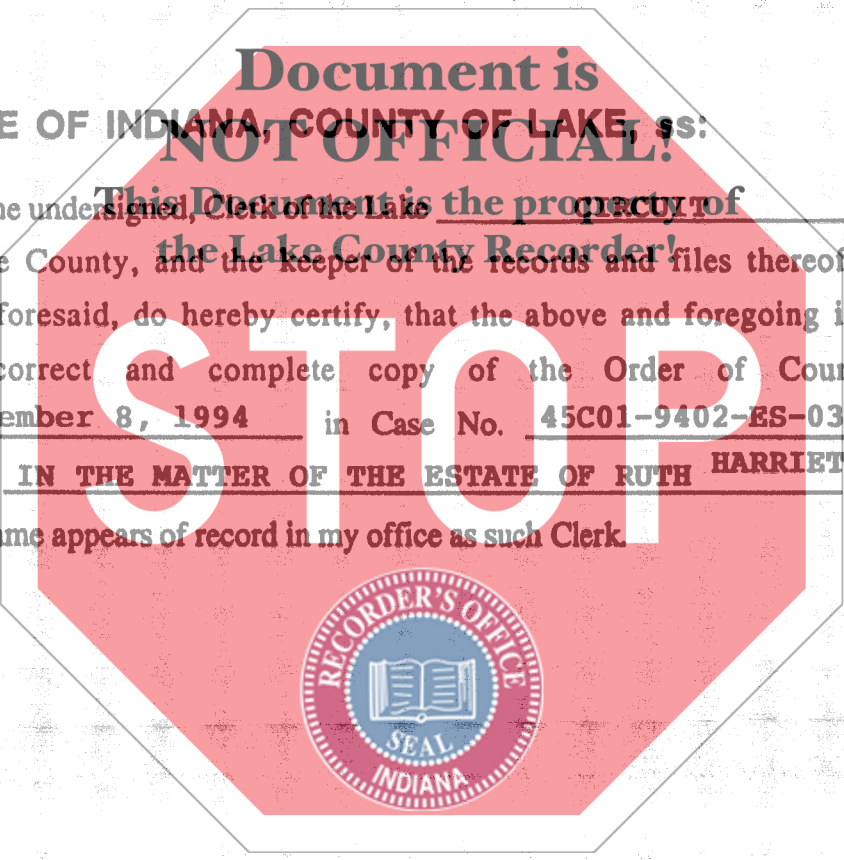
