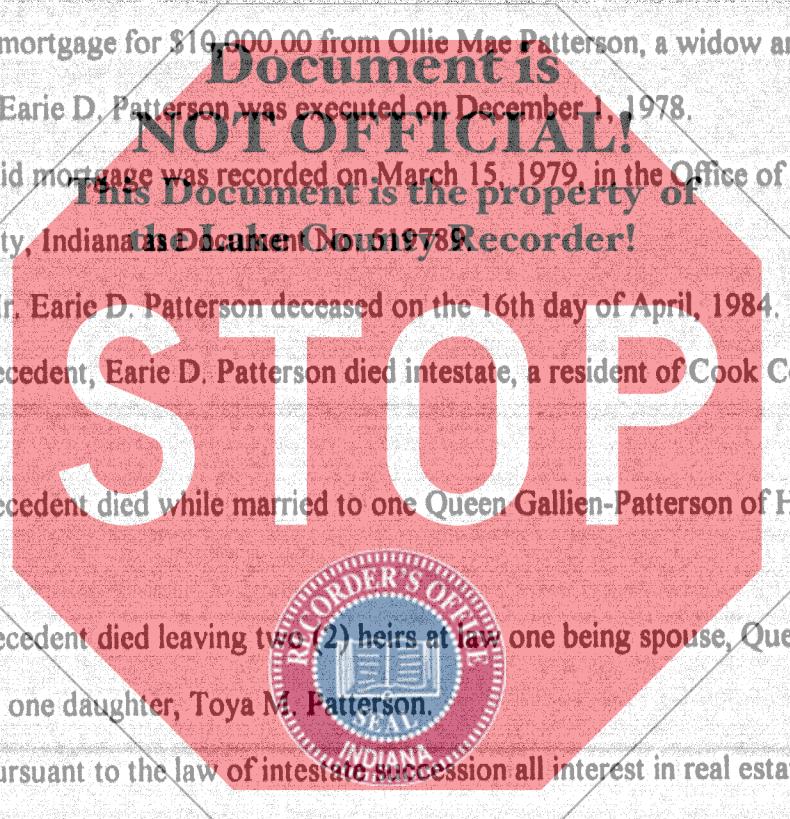

AFFIDAVIT
