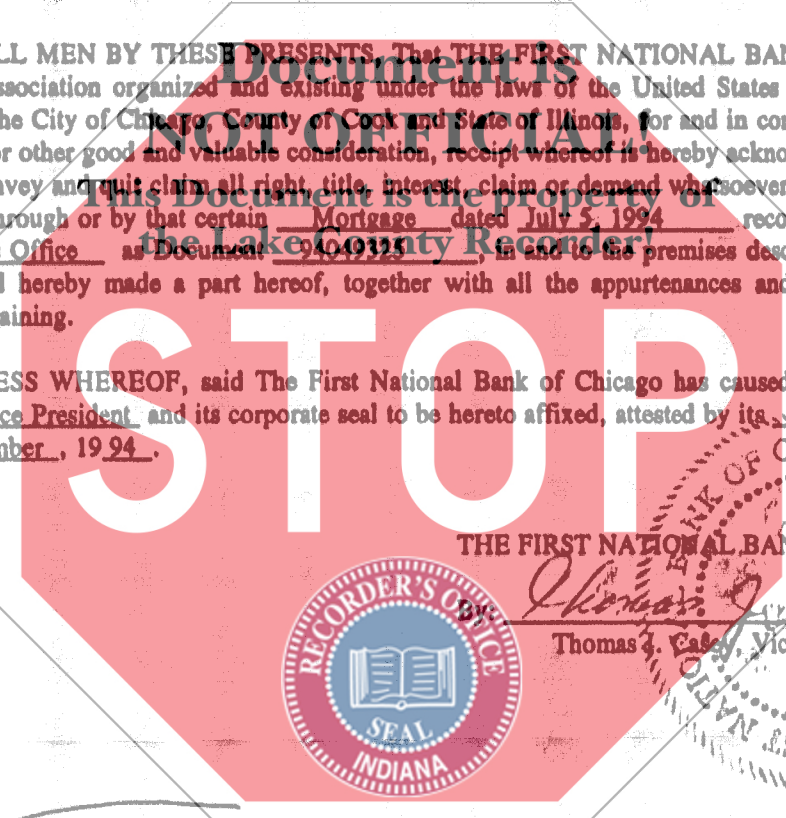

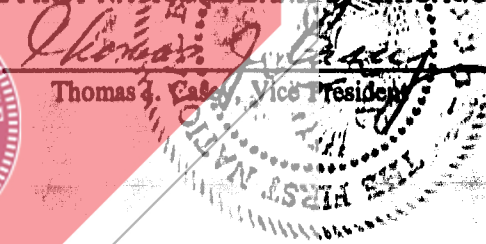
GENERAL RELEASE OF MORTGAGE
