following described real estate in LAKE County, in the State of Indiana:

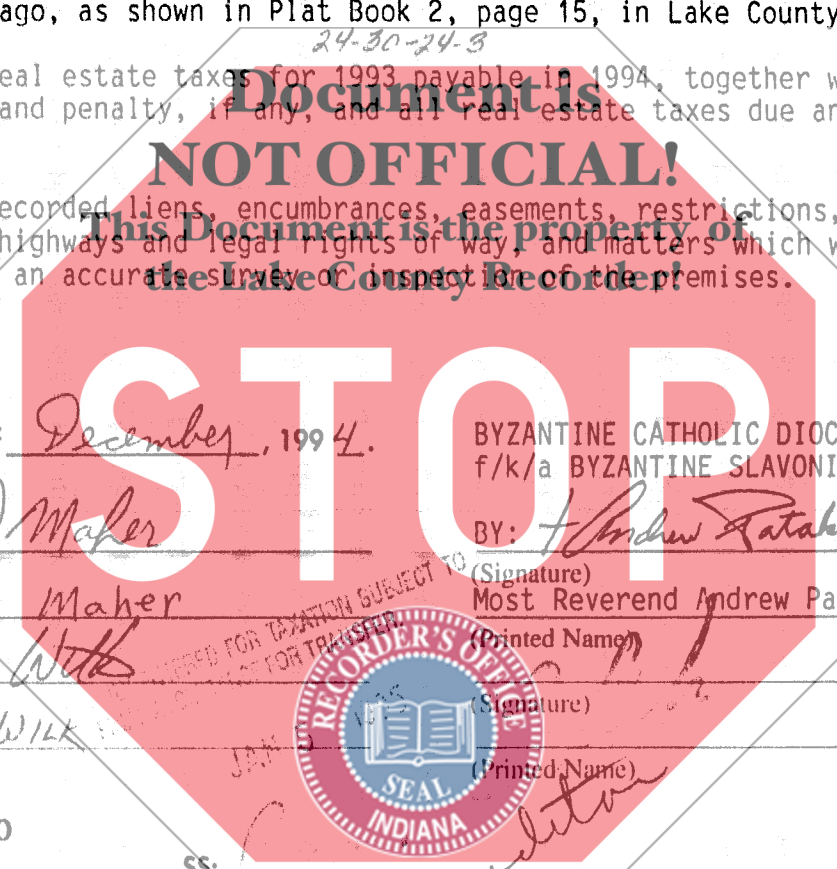
The real estate and premises commonly known as 4317 Indianapolis Boulevard, East Chicago, Lake County, Indiana, more particularly described as follows:
