TRUSTEE'S DEED

THIS INDENTURE WITNESSETH, That DORIS V. MCCLELLAND, Husband and Wife, of Lake County in the State of Indiana, for the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt of which is hereby acknowledged, the following described real estate in Lake County, Indiana:

PARCEL I: The North 2 acres of the West 23 acres of the Southwest Quarter of the Northeast Quarter of Section 23, Township 34 North, Range 9 West of the 2nd P.M. described as commencing at a point at the Northwest corner of the said quarter section running thence South 114.54 feet; thence East 760.66 feet to the East line of said West 23 acres; thence North 114.54 feet; thence West 761.01 feet to the place of beginning.

PARCEL II: Part of the Northwest 1/4 of the Northeast 1/4 of Section 23, Township 34 North, Range 9 West of the 2nd Principal Meridian, described as commencing at the Northwest corner of said tract; thence South 70 rods; thence East 11 3/7 rods; thence North 70 rods; thence West 11 3/7 rods to the place of beginning, in Lake County, Indiana.

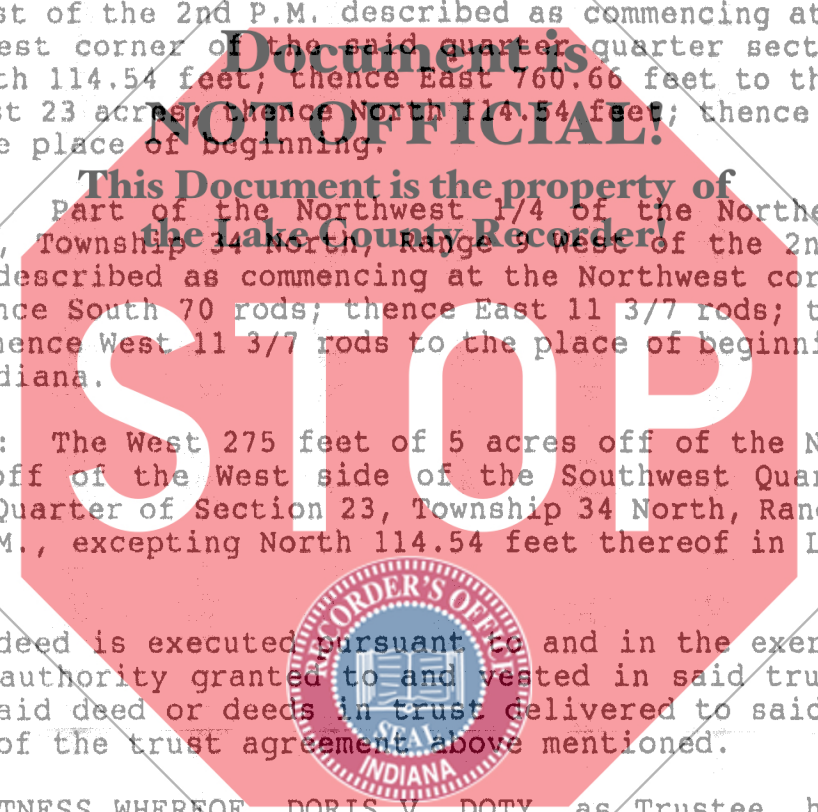
