

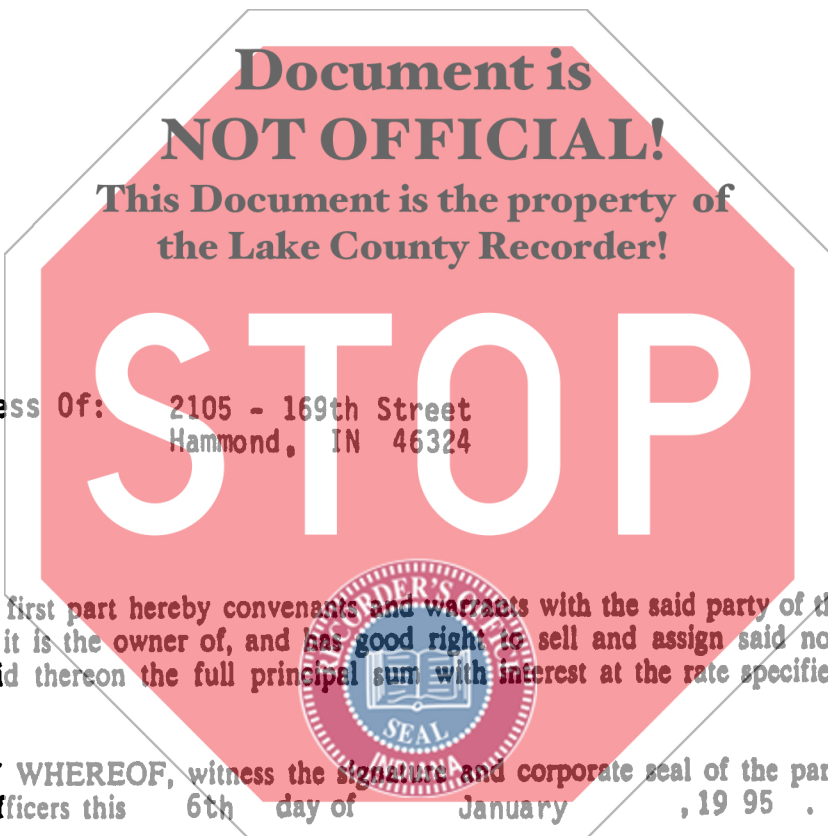
# Assignment of Mortgage
