subsequent to said date.

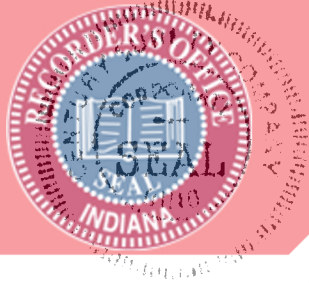

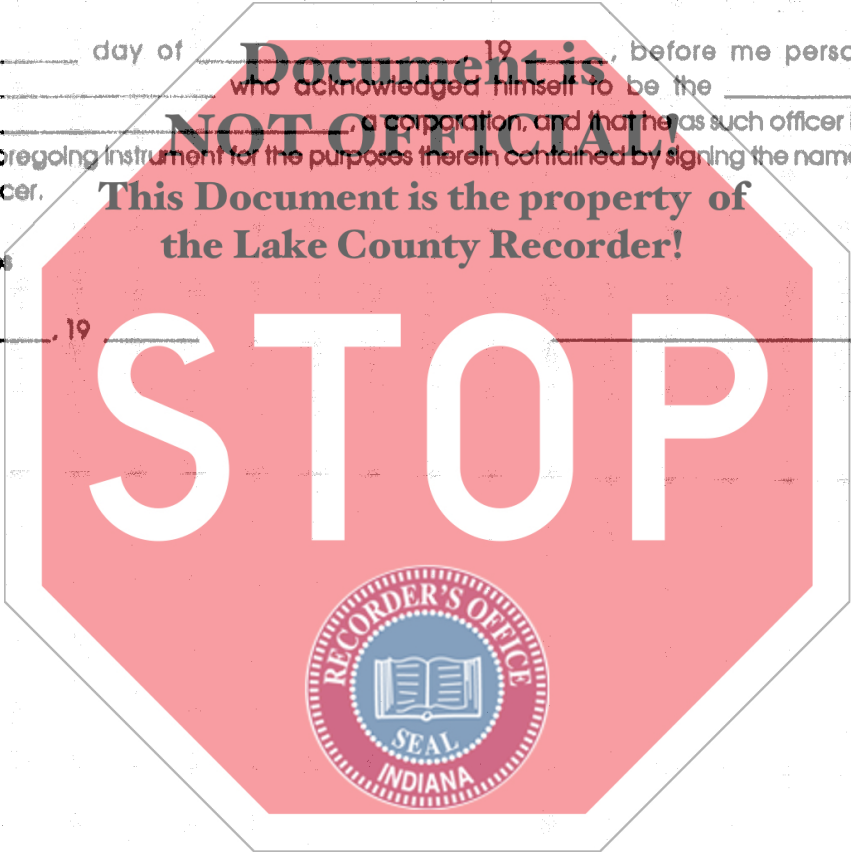
