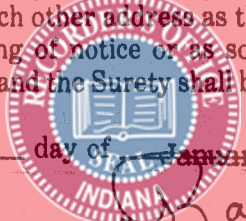
THE CONDITION OF THIS OBLIGATION IS SUCH, That whereas, the Principal has been licensed as an electrician

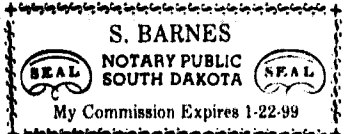
