

# Power of Attorney

**Know All Men by These Presents, That** George n/m/n Carr

**have made, constituted and appointed, and by these presents do make, constitute and appoint** Kevin P. Ray **true and lawful Attorney for**

- a.) Ask, demand, sue for and recover, collect and receive all money, deposits, accounts, interest, dividends and any other credits of whatsoever kind or nature as are now or hereafter shall become due, owing or payable to me and to make, execute and deliver acquittances, receipts, releases, or other discharges therefor;
- b.) Settle, adjust or compromise any and all claims, accounts, or debts owing to or by me and to take or deliver all necessary and proper releases therefor;
- c.) Grant, bargain, sell, exchange, lease, mortgage or otherwise convey and part or all of the real estate or personal property now owned or hereafter acquired of any interest, whether legal or equitable, and in my name to make, execute, acknowledge and deliver good and sufficient deeds, leases, deeds of trust, bills of sale, mortgages or other conveyances of the same;
- d.) Deposit money or securities to my account or for collection with any financial institution and to sign or endorse any instrument to effect such deposit and to endorse any instrument to effect such withdrawals;
- e.) Pay any and all taxes, including income taxes, charges and assessments that may be assessed, imposed or levied by any governmental agency and in the connection to make and execute all income tax returns and other tax forms or returns;
- f.) Execute vouchers in my behalf for any and all allowances and reimbursements properly payable to me by the United States, including, but not restricted to allowances and reimbursements for transportation of dependents or for shipment of household effects as authorized by law and regulations and to receive, endorse, and collect the proceeds of checks payable to the undersigned or to his order drawn on the Treasury of the United States;
- g.) Take possession, and order the removal and shipment of any of my property from any post, station, warehouse, depot, dock or other place of storage or safe keeping, governmental or private; and to execute and deliver any release, or other instrument necessary or convenient for such purpose;
