

PARTIAL RELEASE OF MORTGAGE

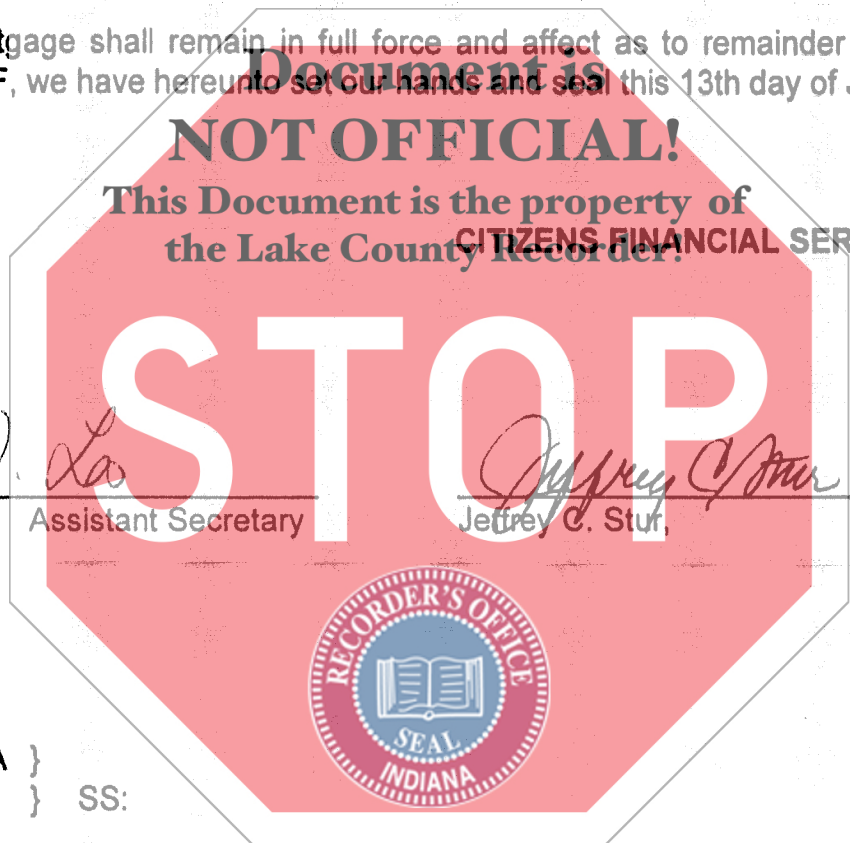
