

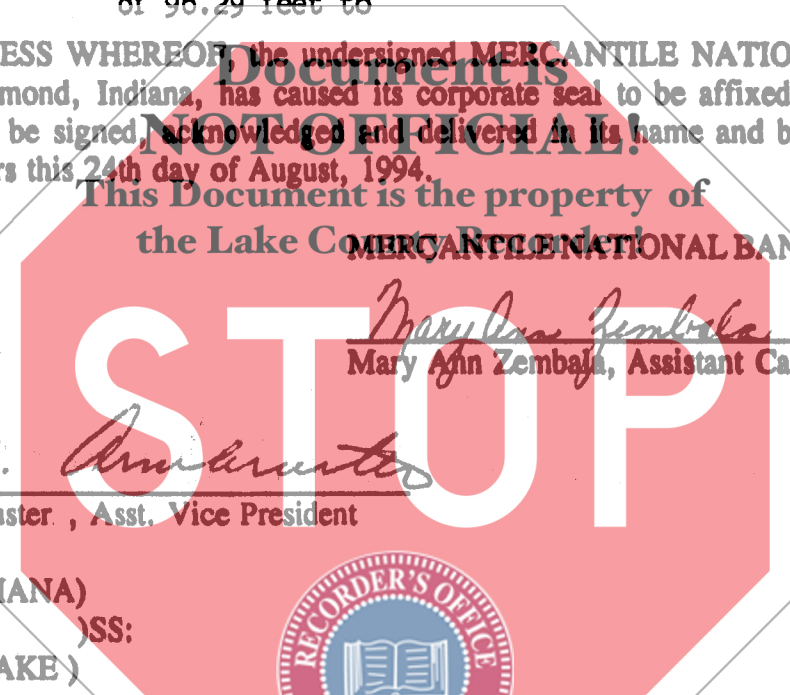
**PARTIAL RELEASE OF MORTGAGE**

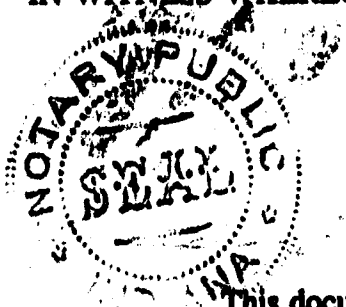
