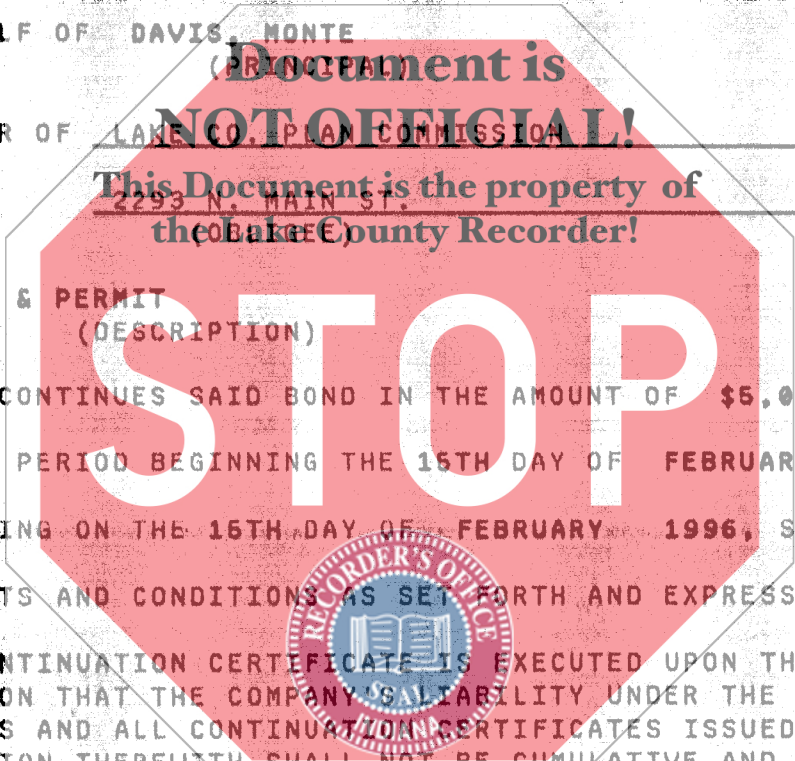

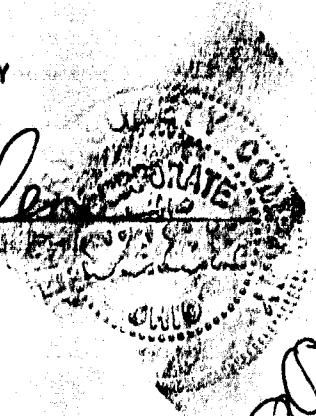

COLUMBUS, OHIO POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS: That the Century Surety Company, organized and existing by virtue of the Laws of the State of Ohio does hereby nominate, constitute and appoint **Gail Kalbus, Dawn M. 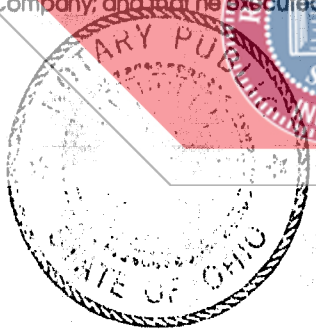

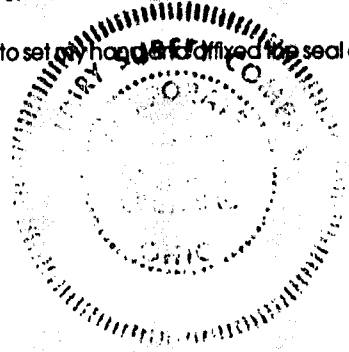
