And the court having examined said petition and being duly advised in the premises now finds that the allegations contained therein are true, and that the prayer of said petition should be granted.

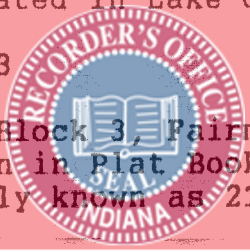
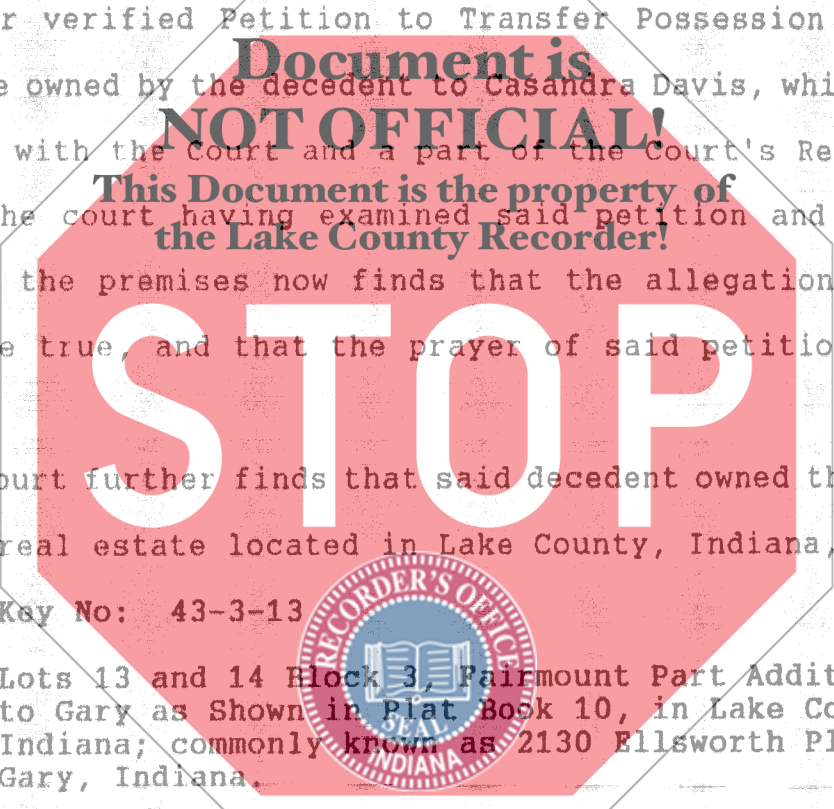
The court further finds that said decedent owned the following described real estate located in Lake County, Indiana, to-wit:
