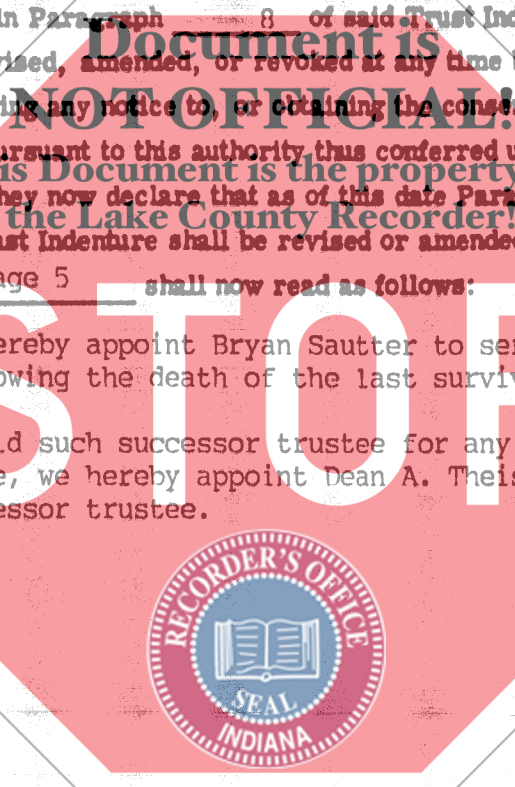
who is the TRUSTEE of the James & Linda Sautter Trust, which

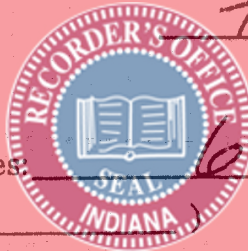
