## **Power of Attorney**

KNOW ALL MEN BY THESE PRESENTS: That STATE FARM FIRE AND CASUALTY COMPANY, an Illinois corporation, with its principal office in Bloomington, Illinois, does hereby constitute and appoint: JEFFREY A PESCHKE its true and lawful Attorney(s)-in-Fact, to make, execute, seal and deliver for, and on its behalf as surety, any and all bonds, undertakings or other writings obligatory in the nature of a bond as follows:

\$1,500 - License, Permit and Indemnity Bonds which guarantee payment.

\$50,000 - Administrator, Executor, Trustee of a decendent's estate

\$10,000 License & Permit which do not guarantee payment - \$25,000 - Guardian, Conservator, Committee \$10,000 - Trustee in Bankruptcy or Receiver Court Bond \$2,000 - Rigingliff's Court Bond

(Code Compliance only) - Public Official 10,000

THIS POWER OF ATTORNEY IS NOT VALID FOR THE EXECUTION OF ANY CONTRACT (CONSTRUCTION OR SUPPLY) BOND - BID, PERFORMANCE OR PAYMENT.

This appointment is made under and by the authority of a resolution which was passed by the Executive Committee of the Board of Directors of State Farm Fire and Casualty Company on the 24th day of July, 1974, as is duly authorized by the Board of Directors in Article II, Section 6 of the By-Laws of the Company, which resolution is:

Resolved, that the Executive Vice-President or a Vice-President of the Company is hereby authorized to appoint and empower any representative of the Company or other person or persons as Attorney-in-Fact to execute on behalf of the Company any bonds, undertakings, policies, contracts of indemnity or other writings obligatory in the nature of a bond, which the Company might execute through its duly elected

Any such power and sealed and certificate so executed and sealed shall, with respect to any bond or undertaking to which it is attached, continue to be valid any binding on the Company.
