AFFIDAVIT OF MERGER AND NAME CHANGE OF BANKS

- 1. He is Executive Vice President of FIRST OF AMERICA BANK CORPORATION ("FABC"), 211 South Rose Street, Kalamazoo, Michigan 49007, a corporation organized and existing under the laws of Michigan.
- 2. FABC is the parent corporation and owns all of the outstanding stock of FIRST OF AMERICA BANK-ILLINOIS, NATIONAL ASSOCIATION, formerly known as FIRST OF AMERICA BANK-NORTHEAST ILLINOIS, NATIONAL ASSOCIATION ("NORTHEAST").
- 3. FABC was the parent corporation and owned all of the outstanding stock of FIRST OF AMERICA BANK-CHAMPAIGN, NATIONAL ASSOCIATION ("CHAMPAIGN"), FIRST OF AMERICA BANK-CHAMPION, NATIONAL ASSOCIATION ("CHAMPION"), FIRST OF AMERICA BANK-DECATUR, NATIONAL ASSOCIATION ("DECATUR"), FIRST OF AMERICA BANK-ILLINOIS, NATIONAL ASSOCIATION ("METRO"), FIRST OF AMERICA BANK-METRO SOUTHWEST, NATIONAL ASSOCIATION ("METRO"), FIRST OF AMERICA BANK-NORTH CENTRAL ILLINOIS, NATIONAL ASSOCIATION ("NORTH CENTRAL"), FIRST OF AMERICA BANK-QUAD CITIES, NATIONAL ASSOCIATION ("QUAD CITIES"), AND FIRST OF AMERICA BANK-SPRINGFIELD, NATIONAL ASSOCIATION ("SPRINGFIELD").
- 4.
