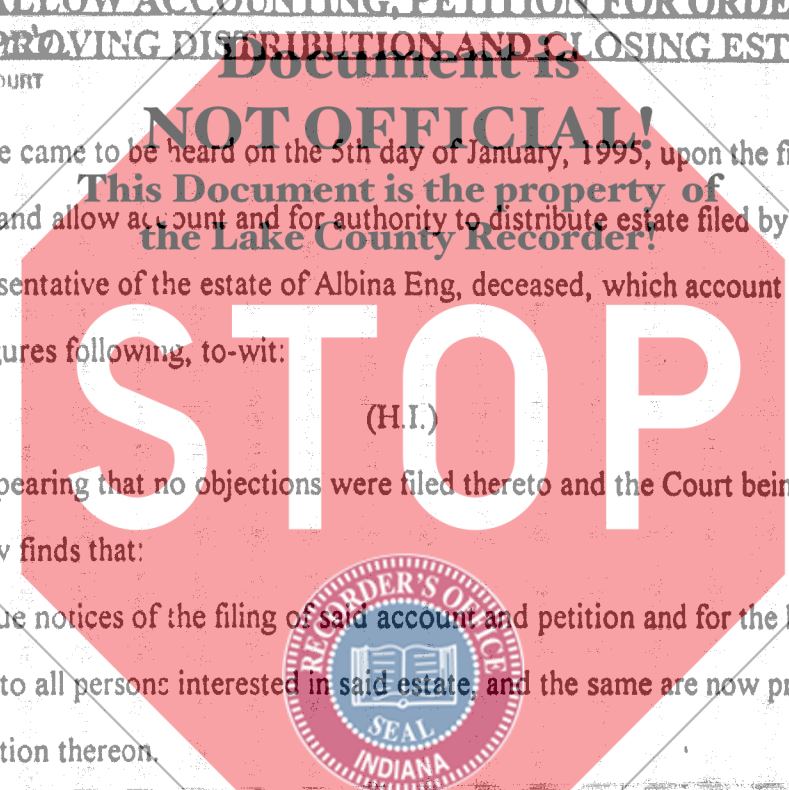

3. That the matters and things stated in said account and petition are true and that said personal representative has accounted for all of the assets in this estate coming into her hands.

4. More than five (5) months have elapsed since the date of the first published notice to legatees, devisees, and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her personal representative were employees of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. The following persons are the heirs at law:

and all assets and property of this estate remaining after payment of decedent's debts and expenses of administration have been distributed to the above-named person.

6. That the decedent owned certain parcels of real estate as follows:

Parcel No. 1: Lot 55 feet of Lots 1, 2, 3, 4 and 5 in Block 13 in Lake Shore Addition to East Chicago in the City of Gary, Lake County, Indiana. (commonly known as 9115 Oak Avenue, Gary, Indiana)

and that said parcel number 1 above has been sold pursuant to this Court's Order dated November 17, 1994, and that said parcel number 2 shall be transferred to Carol Hadenfelt, pursuant to Indiana law.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED BY THE COURT AS FOLLOWS:

1. Said Final Report and Account of said personal representative is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said personal representative's hands for distribution has been made pursuant to the distribution set forth in the final accounting as prescribed pursuant to Indiana law and is hereby in all things approved.

3. That on the 6th day of December, 1994, Carol Hadenfelt, as Administrator of the Estate of Albina Eng, deceased, filed her Administrator's Final Account and Petition to Settle and Allow Account, Approve Distribution, and Close Estate with this Court and outlined the assets, credits and distribution of the estate.

4. Said Administrator has complied with the terms of this Order and that said Administrator has in all things carried out the provisions of this final decree and is hereby released and discharged from any further liability or responsibility as said Administrator of the Estate of Albina Eng, deceased. 5. That the estate of Albina Eng, deceased, is hereby closed.
