1. GRANT. Grantor hereby mortgages, warrants, assigns and grants a security interest to Lender identified above, in the real property described a Schedule A which is attached to this Mortgage and incorporated herein together with all future and present improvements and fixtures; privilegely hereditaments, and appurtenances; leases, licenses and other agreements; rents, issues and profits; water, well, ditch, reservior and mineral rights and stock and standing timber and crops pertaining to the real property (cumulatively "Property").

2. OBLIGATIONS. This Mortgage shall secure the repayment and performance of all of Borrower's and Grantor's present and future. liabilities, obligations and covenants (cumulatively "Obligations") to Lender pursuant to:

- 3. PURPOSE. This Mortgage and the Obligations described herein are executed and incurred for consumer purpose
- 4. FUTURE ADVANCES. Pursuant to Indiana Code Section 32-8-11-9, future obligations, advances, modifications, extensions, and renewals of any indebtedness made up to the maximum amount secured by this Mortgage shall be secured to the same extent as if the future obligations, advances, modifications, extensions and renewals were made on the date of execution of the Mortgage. The lien of this Mortgage with respect to future advances, modifications, extensions and renewals shall have the priority to which the Mortgage otherwise would be entitled under I.C. 32-1-2-16 without regard to the fact that the future advance, modification, extension, or renewal may occur after the Mortgage is executed.
  - 5. REPRESENTATIONS, WARRANTIES AND COVENANTS. Grantor represents, warrants and covenants to Lender that:
  - (a) Grantor has fee simple title to the Property and has full power to mortgage it, and shall maintain the Property free of all liens, security interests, encumbrances and claims except for this Mortgage and those described in Schedule B which is attached to this Mortgage and incorporated herein by reference and agrees to pay the indebtedness secured by this Mortgage together with interest thereon, on or before the due date without relief from valuation or appraisement laws.
  - (b) Neither Grantor nor, to the best of Grantor's knowledge, any other party has used, generated, released, discharged, stored, or disposed of any hazardous waste, toxic substance, or related material (cumulatively "Hazardous Materials") in connection with the Property or transported any Hazardous Materials to or from the Property. Grantor shall not commit or permit cuch actions to be taken in the future. The term "Hazardous Materials" shall mean any substance, material, or waste which is or becomes regulated by any governmental authority including, but not limited to, (i) petroleum; (ii) friable or nonfriable asbestos; (iii) polychlorinated biphenyls; (iv) those substances, materials or wastes designated as a "hazardous substance" pursuant to Section 311 of the Clean Water Act or listed pursuant to Section 307 of the Clean Water Act or any amendments or replacements to these statutes; (v) those substances, materials or wastes defined as a "hazardous substance" pursuant to Section 1004 of the Resource Conservation and Recovery Act or any amendments or replacements to that statutes or substances, materials or wastes defined as a "hazardous substance" pursuant to Section 100 of the Comprehensive Environmental Response, Compensation and Liability Act, or any amendments or replacements to that statute or any other similar statute, rule, regulation or ordinance now or hereafter in effect;
  - (c) Grantor has the right and is duly authorized to execute and perform its Obligations under this Mortgage and these actions do not and shall not conflict with the provisions of any statute, regulation, ordinance, rule of law, contract or other agreement which may be binding on Grantor at any time;
  - (d) No action or proceeding is or shall be pending or threatened which might materially affect the Property; and
  - (e) Grantor has not violated and shall not violate any statute, regulation, ordinance, rule of law, contract or other agreement which might materially affect the Property (including, but not limited to, those governing Hazardous Materials) or Lender's rights or interest in the Property pursuant to this Mortgage.
- 6. TRANSFERS OF THE PROPERTY OR BENEFICIAL INTERESTS IN BORROWERS. On sale or transfer to any person without the prior written approval of Lender or all or any party of the real property described in Schedule A, or any interest therein, or all or any beneficial interest in Borrower or Grantor (if Borrower or Grantor is not a natural person or persons but is a corporation, partnership, trust, or other legal entity), Lender may, at Lender's option declare the sums secured by this Mortgage to be immediately due and payable, and Lender may invoke any remedies permitted by the promissory note or other agreement or by this Mortgage.
- 7. INQUIRIES AND NOTIFICATION TO THIRD PARTIES. Grantor hereby authorizes Lender to contact any third party and make any inquiry pertaining rantor's financial condition or the Property. In addition, Lender is authorized to provide oral or written notice of its interest in the Property to any third party.
- 8. INTERFERENCE WITH LEASES AND OTHER AGREEMENTS. Grantor shall not take or fall to take any action which may cause or permit the termination or the withholding of any payment in connection with any lease or other agreement ("Agreement") pertaining to the Property. - 9. COLLECTION OF INDEBTEDNESS FROM THIRD PARTY. Lender shall be entitled to notify or require Grantor to notify any third party (including, but not limited to, lessees, licensees, governmental authorities and insurance companies) to pay Lender any indebtedness or obligation owing to Grantor with respect to the Property (cumulatively "Indebtedness") whether or not a default exists under this Mortgage. Grantor shall diligently collect the indebtedness owing to Grantor from these third parties until the giving of such notification. In the event that Grantor possesses or receives possession of any instrument or other remittances with respect to the indebtedness following the giving of such notification or if the instruments or other remittances constitute the prepayment of any indebtedness or the payment of any insurance or condemnation proceeds, Grantor shall hold such instruments and other remittances in prepayment or any indeptedness or the payment of any insurance of condemnation proceeds, Grantor shall not during insurances and other remittances to Lender, and immediately provide Lender with possession of the instruments and other remittances. Lender shall be entitled, but not required to collect (by legal proceedings or otherwise), extend the time for payment, compromise, exchange or release any obligor or collateral upon, or otherwise settle any of the indebtedness whether or not an event of default exists under this Agreement. - 10. USE AND MAINTENANCE OF PROPERTY. Grantor shall take all actions and make any repairs needed to maintain the Property in good condition. Grantor shall not commit or permit any weste to be committed with respect to the Property. Grantor shall use the Property solely in compilance with applicable law and insurance policies. Grantor shall not make any alterations, additions or improvements to the Property without Lander's prior written consent. Without limiting the foregoing, all alterations, additions and improvements made to the Property shall be subject to the interest belonging to Lander, shall not be removed without Lander's prior written consent, and shall be made at Grantor's sole expense.
- 11. LOSS OR DAMAGE. Granter shall bear the entire risk of any loss, theft, destruction or damage (cumulatively "Loss or Damage") to the Property or any portion thereof from any case whatsoever. In the event of any Loss or Damage, Granter shall, at the option of Lender, repair the affected Property to its previous condition or pay or cause to be paid to Lender the decrease in the fair market value of the affected Property.
- 12. INSURANCE. The Property will be kept insured for its full value against all hazards including loss or damage caused by fire, collision, theft or other casualty. Grantor may obtain insurance on the Property from such companies as are acceptable to Lander in its sole discretion. The insurance policies shall require the insurance company to provide Lander with at least thirty (30) days' written notice before such policies are altered or cancelled in any manner. The insurance policies shall name Lander as a loss payee and provide that no act or omission of Grantor or any other person shall affect the right of Lander to be paid the insurance proceeds pertaining to the loss or damage of the Property. In the event Grantor falls to acquire or maintain insurance, Lander (after providing notice as may be required by law) may in its discretion procure appropriate insurance coverage upon the Property and charge the insurance cost as an advance of principal under the promiseory note. Grantor shall furnish Lander with evidence of insurance indicating the required coverage. Lander may act as attorney-in-fact for Grantor in making and settling claims under insurance policies, cancelling any policy or endorsing Grantor's name on any draft or negotiable instrument drawn by any insurer.
- 13. ZONING AND PRIVATE COVENANTS. Grantor shall not initiate or consent to any change in the zoning provisions or private covenants affecting the use of the Property without Lender's prior written consent. If Grantor's use of the Property becomes a nonconforming use under any zoning provision, Grantor shall not cause or permit such use to be discontinued or abandoned without the prior written consent of Lender. Grantor will immediately provide Lender with written notice of any proposed changes to the zoning provisions or private covenants affecting the Property.
- 14. CONDEMNATION. Grantor shall immediately provide Lander with written notice of any actual or threatened condemnation or eminent domain proceeding pertaining to the Property. All monies payable to Grantor from such condemnation or taking are hereby assigned to Lender and shall be applied first to the payment of Lander's attorneys' fees, legal expenses and other costs (including appraisal fees) in connection with the condemnation or eminent domain proceedings and then, at the option of Lender, to the payment of the Obligations or the restoration or repair of the Property.
- 15. LENDER'S RIGHT TO COMMENCE OR DEFEND LEGAL ACTIONS. Grantor shall immediately provide Lander with written notice of any actual or threatened action, sult, or other proceeding affecting the Property. Grantor hereby appoints Lander as its attorney-in-fact to commence, intervene in, and defend such actions, sults, or other legal proceedings and to compromise or settle any claim or controversy pertaining thereto. Lander shall not be liable to Grantor for any action, error, mistaire, omission or delay pertaining to the actions described in this paragraph or any damages resulting therefrom. Nothing centained herein will prevent Lander from taking the actions described in this paragraph in its own name.
- 16. MIDENTIFICATION. Lander shall not assume or be responsible for the performance of any of Granter's Obligations with respect to the Property under any discursations. Granter shall immediately provide Lander and its shareholders, officers, employees and agents with written notice of and indemnify and hold Lander harmless from all champes, facilities (including attachers) took and legal expenses), causes of action, actions, suits and other legal proceedings (cumulatively "Claime") pertaining to the Property Encluding, but not firstled to, those involving Hazardous Materials). Granter, upon the request of Lander, shall hire legal expenses and other costs incurred in connection therewith. - 17. TAXES AND ASSESSMENTS. - 19. ESTOPPEL CERTIFICATES. Within ten (10) days after any request by Lendor, Grantor shall deliver to Lendor, or any intended transferse of Lendor's rights with respect to the Obligations, a signod and adminished statement specifying (a) the outstanding balance on the Obligations; and (b) whether Grantor possesses any claims, defenses, set-offs or counterclaims with respect to the Obligations and, if so, the nature or such claims, defenses, set-offs or counterclaims. Grantor will be conclusively bound by any representation; that Lender may make to the intended transferse with respect to these matters in the event that Grantor falls to provide the requested statement in the system.
  - 20. DEFAULT. Grantor shall be in default under this Mortgage in the event that Granter or Borrower;
    - (a) commits fraud or makes a material micropresentation of any time in connection with the Obligations or this Mortgage, including, but not limited to, false statements made by Grantor about Grantor's income, assets, or any other sepects of Grantor's financial condition;
    - (b) falls to meet the repayment terms of the Obligations;
    - (c) violates or fails to comply with a covenant contained in this Mortgage which adversely affects the Property or Lender's rights in the Property, including, but not limited to, transfering title or selling the Property without Lender's consent, failing to maintain insurance or to pay taxes on the Property, allowing a lien senior to Lender's to result on the Property without Lender's written consent, allowing the taking of the Property through eminent domain, allowing the Property to be foreclosed by a lienholder other than Lender, committing waste of the Property, using the Property in a manner which would be destructive to the Property, or using the property in an illegal manner which may subject the Property to seizure or confiscation.
- 21. RIGHTS OF LENDER ON DEFAULT. If there is a default under this Mortgage, Lender shall be entitled to exercise one or more of the following remedies without notice or demand (except as required by law):
  - (a) to terminate or suspend further advances or reduce the credit limit under the promiseory notes or agreements evidencing the obligations;
  - (b) to declare the Obligations immediately due and payable in full;
  - (c) to collect the outstanding Obligations;
  - (d) to require Grantor to deliver and make available to Lender any personal property constituting the Property at a place reasonably convenient to Grantor and Lender;
  - (e) to take immediate possession, management and control of the Property without seeking the appointment of a receiver;
  - (f) to collect all of the rents, issues, and profits from the Property from the date of default through the expiration of the last redemption period following the foreclosure of this Mortgage;
  - (g) to apply for and obtain, without notice and upon ex parte application, the appointment of a receiver for the Property without regard to Grantor's financial condition or solvency, the adequacy of the Property to secure the payment or performance of the Obligations, or the existence of any waste to the Property;
  - (h) to foreclose this Mortgage without relief from valuation or appraisement laws;
  - (i) to set-off Grantor's Obligations against any amounts due from Lender including, but not limited to, monies, instruments, and deposit accounts maintained with Lender; and
  - (1) to exercise all other rights available to Lender under any other written agreement or applicable law.

Lender's rights are cumulative and may be exercised together, separately, and in any order. In the event that Lender institutes an action seeking the recovery of any of the Property by way of a prejudgment remedy in an action against Grantor, Grantor waives the posting of any bond which might otherwise be required.

- 22. APPLICATION OF PORECLOSURE PROCEEDS.
