## **DEED IN TRUST**

This conveyance is made upon the express understanding and condition that Ronald A. Lynch and Maryrose Lynch, individually, or as Trustees, nor their successor or successors in trust shall incur any personal liability or be subjected to any claim, judgment or decree for anything they or their agents or attorneys may do or omit to do in or about the real estate or under the provisions of this Deed or the Trust Agreement or any amendment thereto, or for injury to person or property happening in or about the real estate, any and all such liability being hereby expressly waived and released. Lynch and Maryrose Lynch, as Trustees, the entire legal and equitable title in fee simple, in and to all of the real estate above described.
