Comes now Karen Murray, being duly sworn upon her oath, and states as follows:

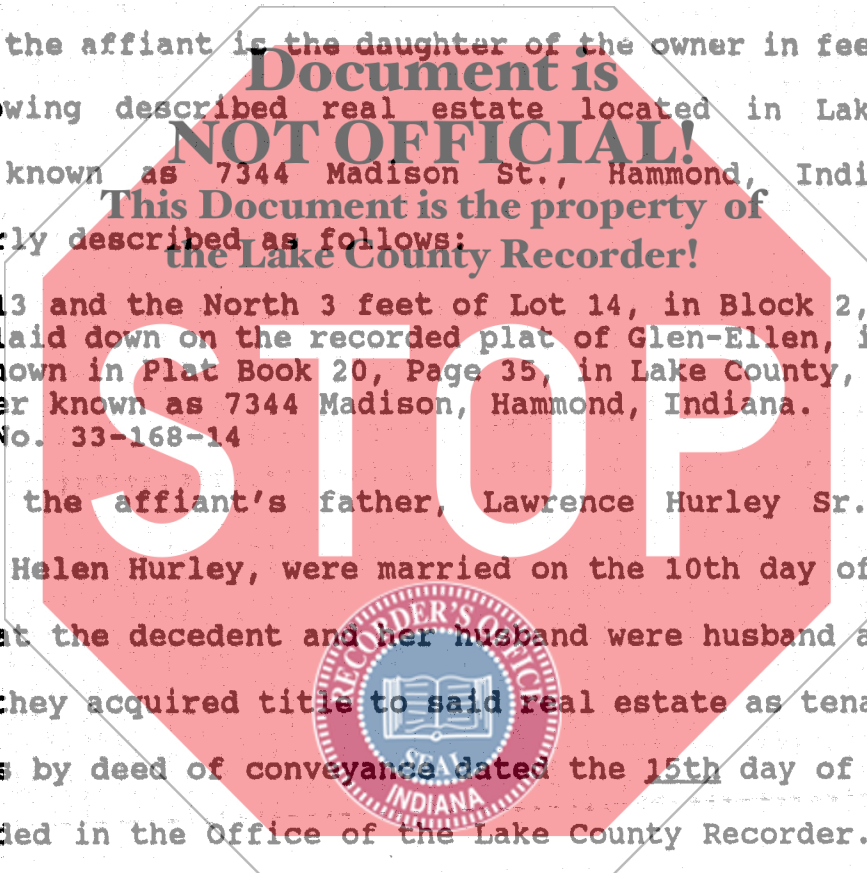
