DECREE FOR SUMMARY DISSOLUTION OF MARRIAGE

Petitioner appears in person and by her attorney, BRUCE J. BERKMAN, and shows service of summons on the Respondent herein, together with a copy of the Petition for Dissolution of Marriage, (H.I.). Parties file waiver of final hearing (H.I.). This cause is now submitted for summary dissolution with the intervention of a jury, and the Court now finds:

1. That there has been an irretrievable breakdown of the marriage of the Parties and said marriage should be dissolved.
2. That this cause is set for summary hearing sixty days from the filing of the original petition.
3. That the Petitioner was a resident of Lake County Indiana, six months preceding the filing of the petition herein.
4. That no children were born of the marriage between the Parties, and the Petitioner is not now pregnant.
5. That the Parties acquired real property during the marriage; have previously made division of the personal property and, that certain debts remain of the marriage of the Parties.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED BY THE COURT:

1. That the marriage of the Parties herein is hereby dissolved.

Upon the Respondent paying off the current balances due to Montgomery Ward, Wickes Furniture, Carpenters Federal Credit Union, American General Finance, Visa, Discover Card, Spiegel's, and Lafayette National Bank n/k/a INB, Petitioner shall execute a quit claim deed conveying her interest in the real estate to the Respondent.


3. That the Petitioner shall be responsible for the marital debt to Lerner's and Methodist Hospital-Southlake and shall hold the Respondent harmless therefrom.
