White, its behalf, and as its act and deed any and all bonds and undertakings of suretyship, and to bind the GENERAL ACCIDENT INSURANCE COMPANY OF AMERICA hereby as fully and to the same extent as if such bonds and undertakings and other writings obligatory in the nature thereof were signed by an Executive Officer of the GENERAL ACCIDENT INSURANCE COMPANY OF AMERICA and sealed and attested by one other of such officers, and hereby ratifles and confirms all that its said Attorney(s)-in-fact may do in pursuance hereof; provided that any bond or undertaking of suretyship executed under this authority shall be subject to the following limitations: Any Plantiff's Court Bond in an amount not to exceed\$ 100,000 Any Public Official Bond (excluding blanket) in an amount not to exceed Any Cost on Appeal or Removal Bond in an amount not to exceed This power of attorney is granted under and by authority of Subsection 5.1(b) of Article V of the by-laws of GENERAL ACCIDENT INSURANCE COMPANY OF AMERICA which became effective Echium 20, 1992 and which provisions are in full force and effect, reading as follows: "5.1 (b) The Board of Direction or President, Vice President, or other efficer designated by them on either of them shall have power to appoint Attorneys-in-Fact and to authorize them to execute on behalf of the Company bonds and undertaking, recognization, incompanies of indertriby and other whitings obligatory in the nature theraf, and to attach the seal of the Company thereto; and shall also have power to remove any such Attorney-in-Fact at any time and revoks the power and authority given to him.
