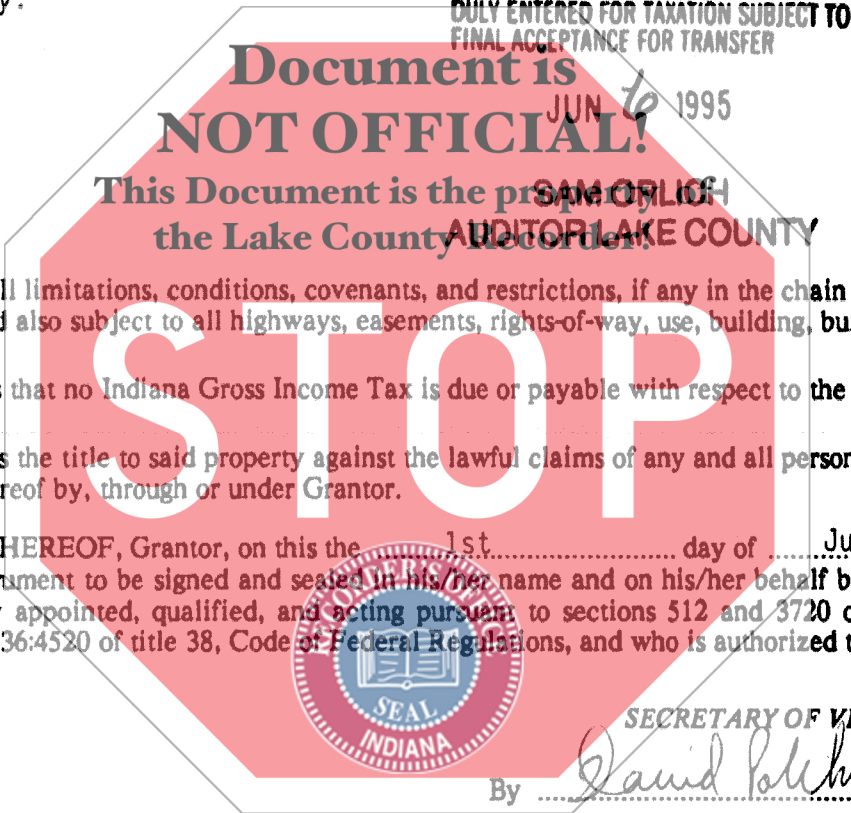
SPECIAL WARRANTY DEED
