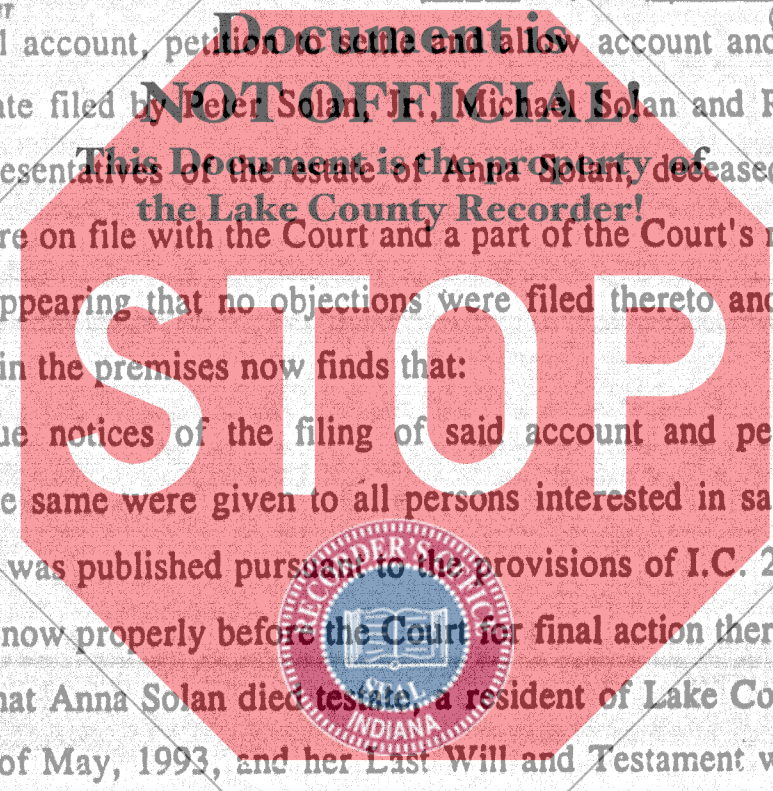

This case came to be heard on the 23 day of May, 1995,

upon the final account, petition to settle and allow account and for authority to distribute estate filed by Peter Solan, Jr., Michael Solan and Richard Solan, as personal representatives of the estate of Anna Solan, deceased, which account and petition are on file with the Court and a part of the Court's records.



And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate. That formal notice was published pursuant to the provisions of I.C. 29-1-16-6 and that this matter is now properly before the Court for final action thereon.

2. That Anna Solan died testate, a resident of Lake County, Indiana, on the 18th day of May, 1993, and her Last Will and Testament was duly admitted to probate before this Court on the 19th day of October, 1993, and this Court appointed said Peter Solan, Jr., Michael Solan and Richard Solan as personal representatives of the Last Will and Testament of the decedent, and said personal representatives were issued Letters Testamentary on the 19th day of October, 1993, and since that date they have continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said personal representatives have accounted for all the assets in said estate coming into their hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her personal representatives were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. The following persons are the legatees and devisees under the decedent's Last Will and Testament: Peter Solan, Jr., Michael Solan and Richard Solan, and that all assets and property of this estate remaining after payment of decedent's debts and expenses of administration should be distributed to the above-named parties in equal shares.

6. That the decedent owned real estate located 1134 Spruce Street, Hammond, Indiana 46324, more particularly described as follows:

East 1/2 of Lot 3, Block 4, in Columbia Gardens in the City of Hammond, as per plat thereof recorded in Plat Book 15, Page 2, in the Office of the Lake County Recorder.

And that said real estate was devised to Peter Solan, Jr., Michael Solan and Richard Solan as a part of decedent's residuary estate under Article III of her Last Will and Testament. That the devisees have agreed that the Lake County, Indiana real estate will be devised solely to Peter Solan, Jr.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said personal representatives is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said personal representatives' hands for distribution should be made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That the real estate owned by decedent is hereby vested as follows:

To Peter R. Solan, Jr.:

East 1/2 of Lot 3, Block 4, in Columbia Gardens in the City of Hammond, as per plat thereof recorded in Plat Book 15, Page 2, in the Office of the Lake County Recorder.

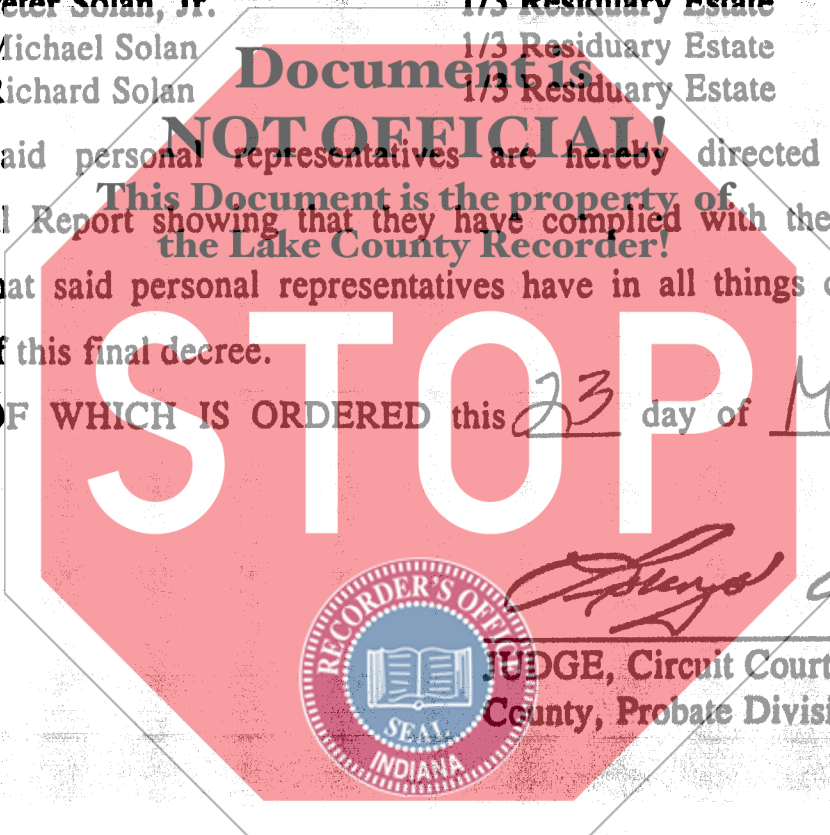
