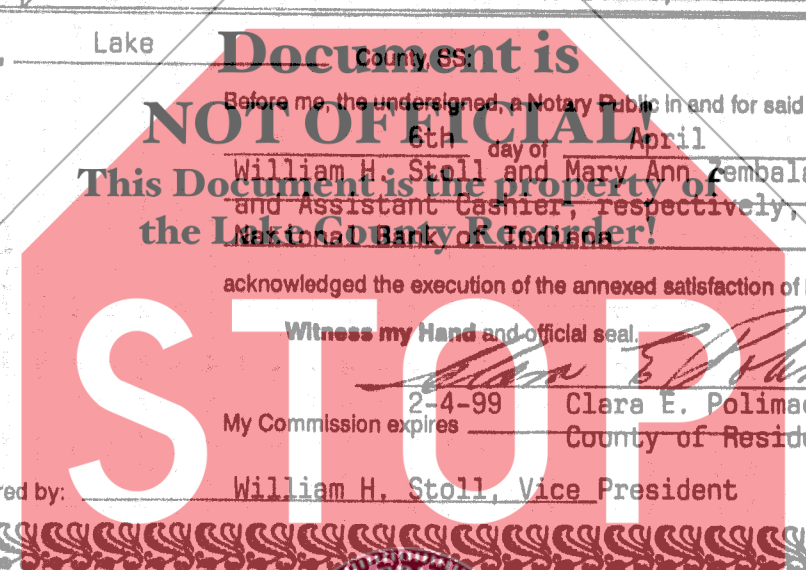

PARCEL I: The West 100 feet of part of the Southwest Quarter of Section 26, Township 37 North, Range 9 West of the 2nd Principal Meridian, described as follows: Beginning at a point on the South right of way line of the Baltimore and Ohio Chicago Terminal Railroad, 1524.88 feet East of the West line of the Southwest Quarter of said Section 26; (measured along said South right of way line); thence continuing East along said South right of way line 472.47 feet; thence South and parallel with the West line of the Southwest Quarter of said Section 26, a distance of 329.74 feet to a point 70 feet North of the center line of Chicago Avenue; thence West and parallel with the South right of way line of the Baltimore and Ohio Chicago Terminal Railroad 472.47 feet; thence North and parallel with the West line of the Southwest Quarter of said Section 26, a distance of 329.74 feet to the place of beginning, all in the City of Gary, in Lake County, Indiana.
