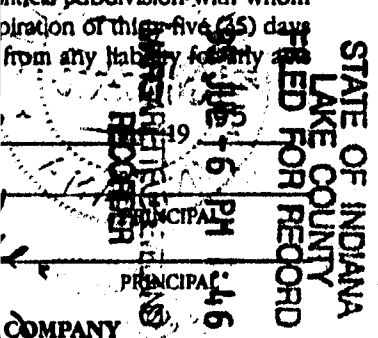
NOW THEREFORE, if the said Principal shall faithfully perform the duties and in all things comply with the laws and ordinances, includ-

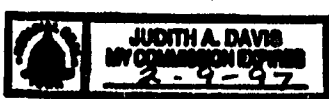

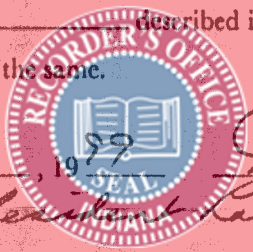
