Lot 98, Unit 4, Block 3, Eastdale Estates, as shown in Plat Book 70, page 11, Lake County, Indiana.

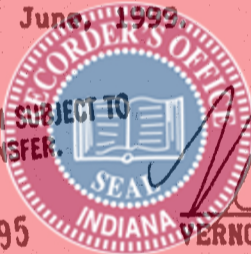
