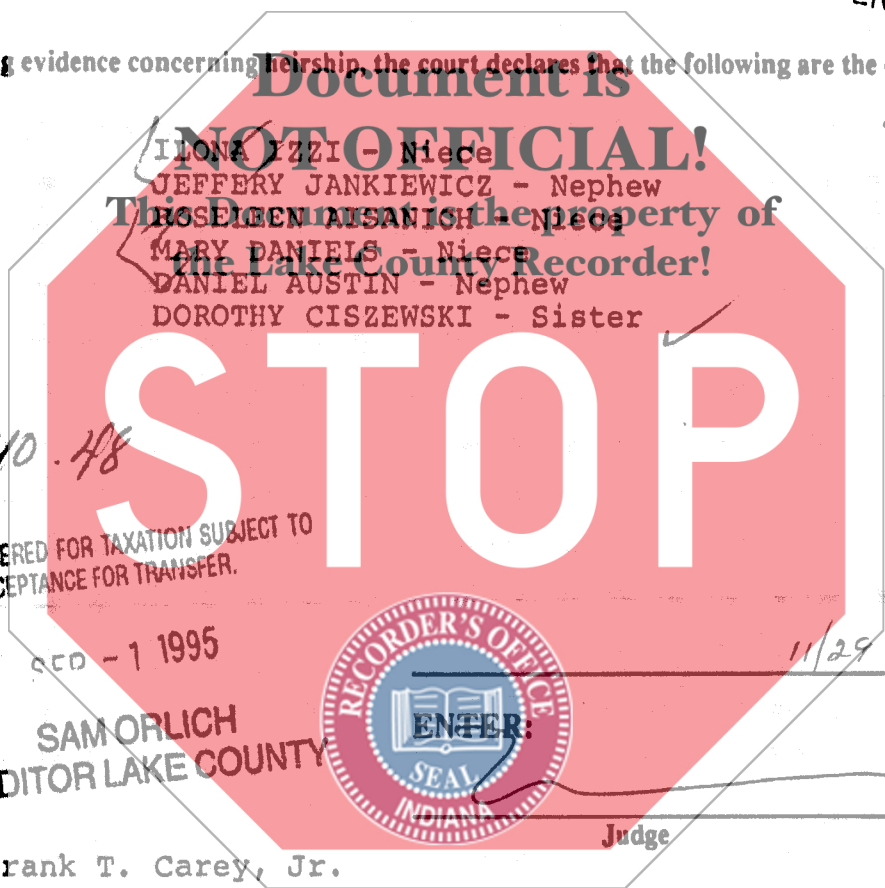

### AFFIDAVIT OF HEIRSHIP

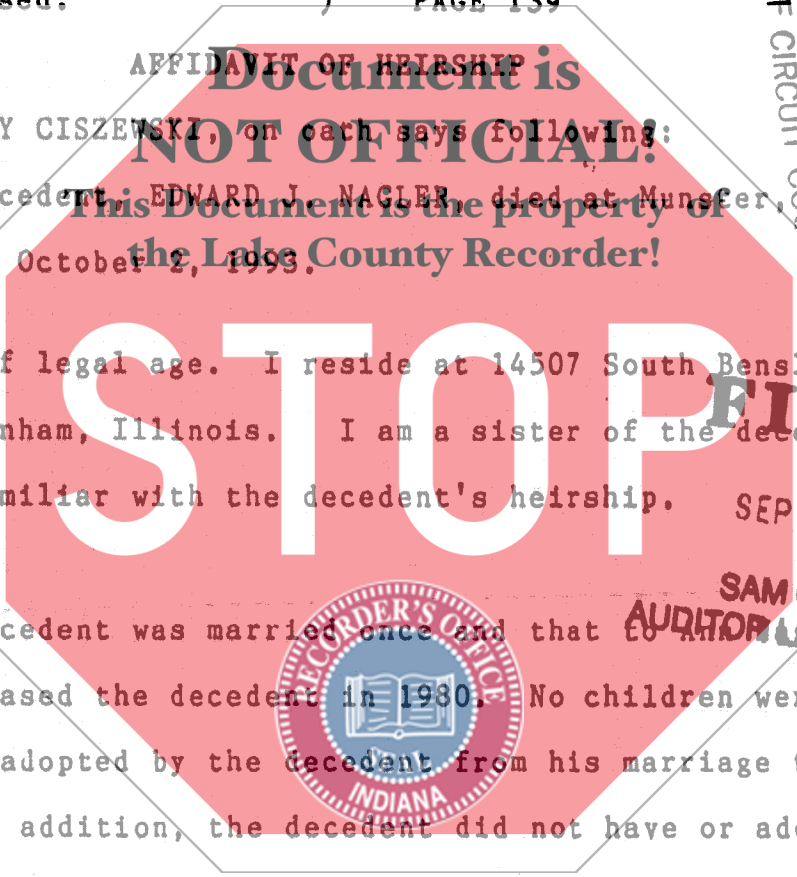
DOROTHY CISZEWSKI, on oath, says following:

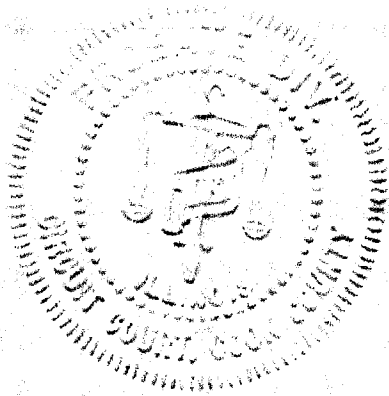
