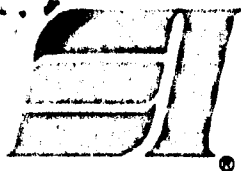

 of General contractor

NOW THEREFORE, if the said Principal shall faithfully perform the duties and in all things comply with the laws and ordinances,
 including all Amendments thereto, pertaining to the license or permit being granted, then this obligation is to be void, otherwise to
 remain in full force and effect until September 5, 1996, unless renewed by Continuation Certificate.

PROVIDED, HOWEVER, This bond may be cancelled by the Surety thirty (30) days after receipt by the Obligee of the Surety's
 written notice of cancellation sent by Certified Mail.

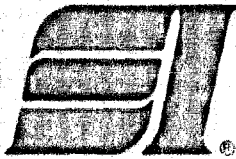

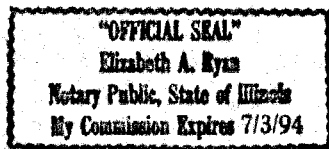
