effective unless made by written endorsement issued to form a part hereof.

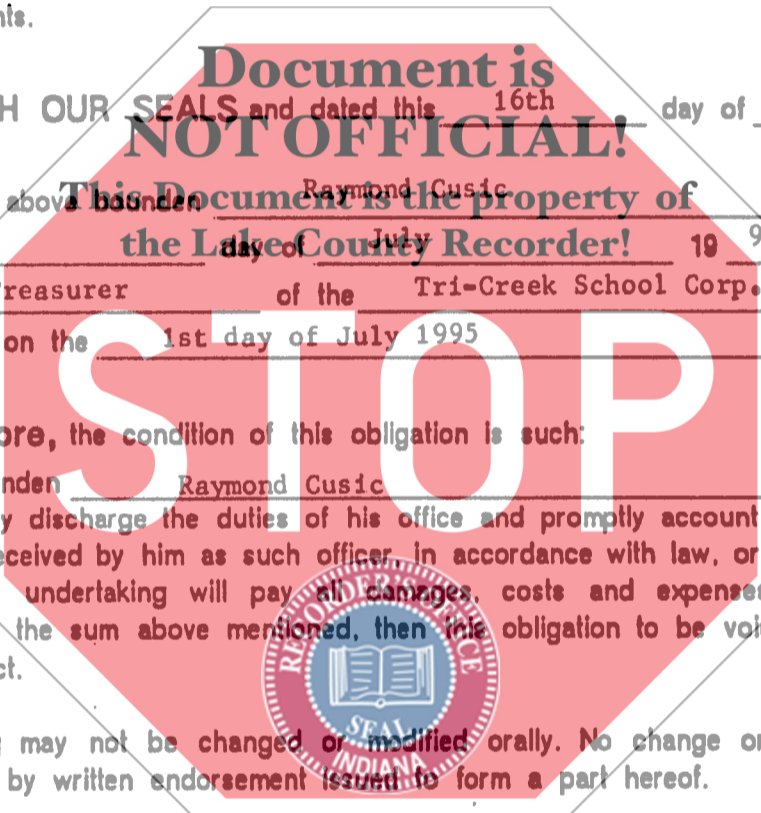
