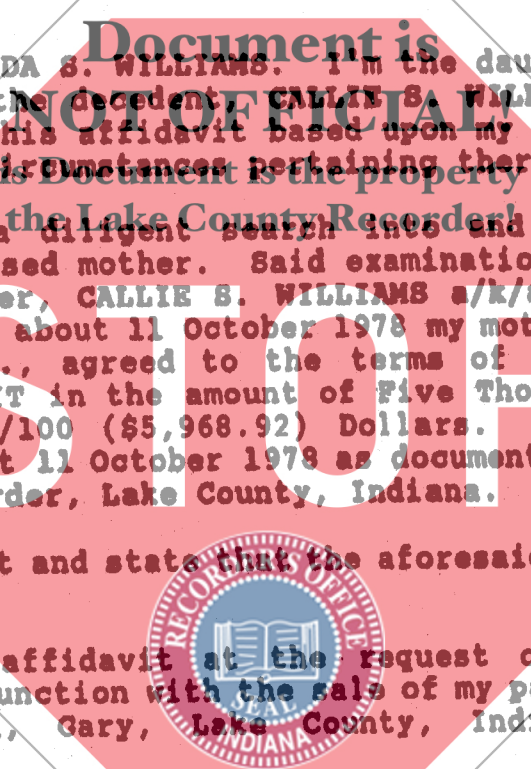
I hereby attest and state that the aforesaid mortgage has been paid in full.
