Mortgage Company changed its name to A Mortgage Company on May 28, 1991.

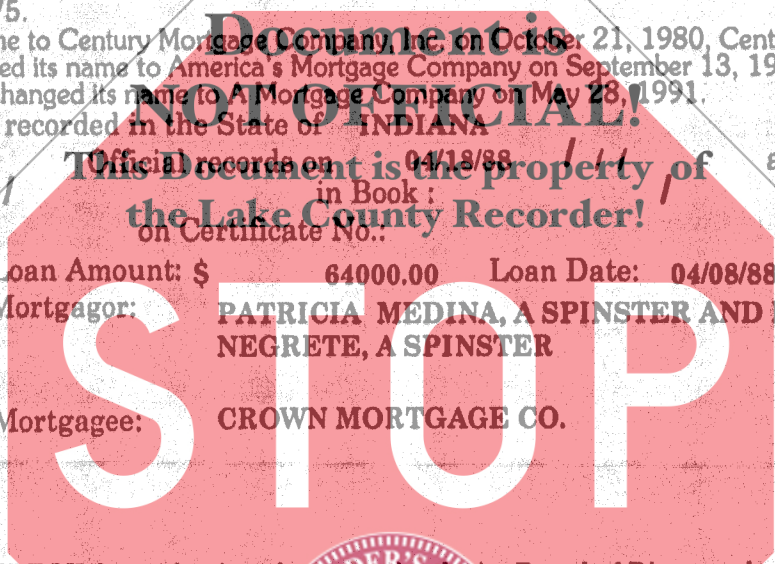
