**AMENDMENT TO CONTRACT FOR CONDITIONAL SALE OF REAL ESTATE**

This Agreement made this 12th day of June, 1995, by and between GEORGE T. BRUETTE and MARTHA D. BRUETTE, husband and wife (hereinafter referred to as "Seller") and ANTHONY P. KOUFOS (hereinafter referred to as "Buyer").

**RECITALS**

Seller and Buyer executed a Contract for Conditional Sale of Real Estate dated September 15, 1989 which was recorded on October 2, 1989 as Document No. 060449 in the Office of the Recorder of Lake County, Indiana.

After said Contract for Conditional Sale of Real Estate had been recorded, Seller and Buyer agreed that the legal description contained in, and attached as Exhibit A to said Contract, was erroneous. There were two lots on Parcel I which were inadvertently omitted from said legal description.

Seller and Buyer now agree that two additional lots should be added to the legal description which describes the real estate being sold pursuant to said Contract for Conditional Sale of Real Estate dated September 15, 1989. The legal description of the two lots which are being added at this time is as follows:

Lots 11 and 12 in Block 1 and that portion of Outlot "A" lying North and adjacent to said Lots 11 and 12 in Woodland Shores Addition to Cedar Lake, as per plat thereof, recorded in Plat Book 27, Page 95, in the Office of the Recorder of Lake County, Indiana.

Seller and Buyer hereby ratify and affirm all other terms and conditions as stated in said Contract for Conditional Sale of Real Estate dated September 15, 1989 which was recorded on October 2, 1989 as Document No. 060449 in the Office of the Recorder of Lake County, Indiana.

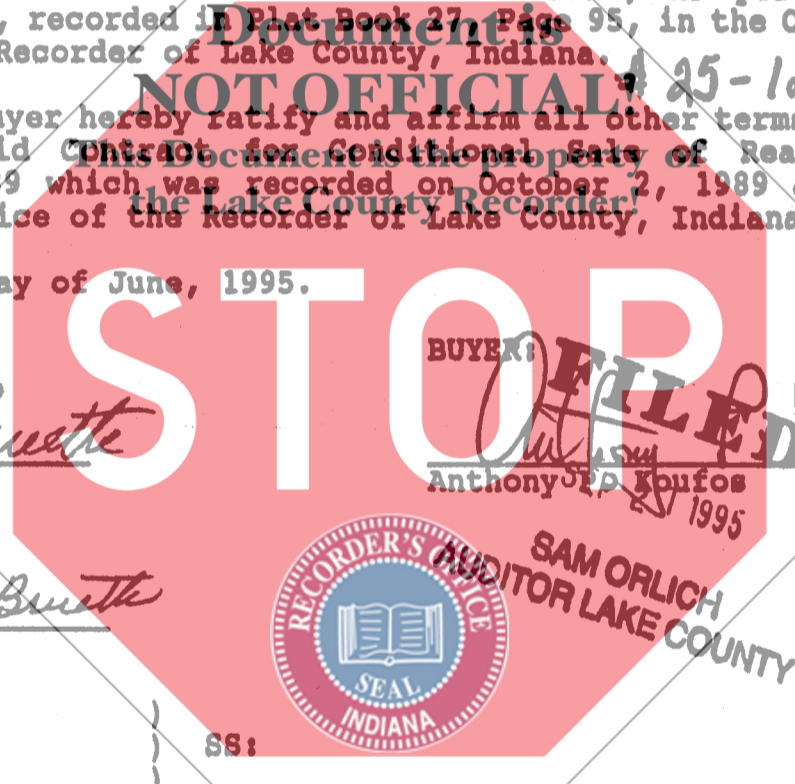
