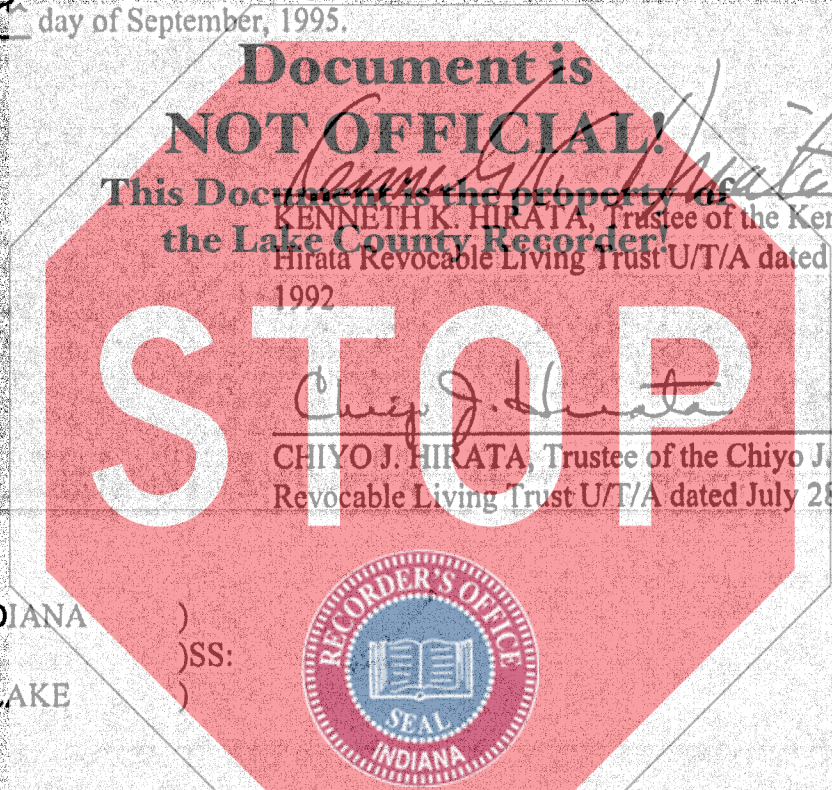

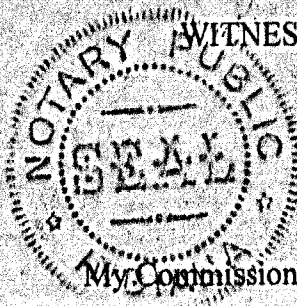

*1-74-12*

**PARCEL 1:** The West 145.0 feet of the South 264.0 feet of the Southwest quarter of Section 22, Township 33 North, Range 9 West of the 2nd Principal Meridian, in Lake County, Indiana.

*1-74-11*

**PARCEL 2:** The East 100.0 feet of the West 245.0 feet of the South 264.0 feet of the Southwest quarter of Section 22, Township 33 North, Range 9 West of the 2nd Principal Meridian, in Lake County, Indiana.
