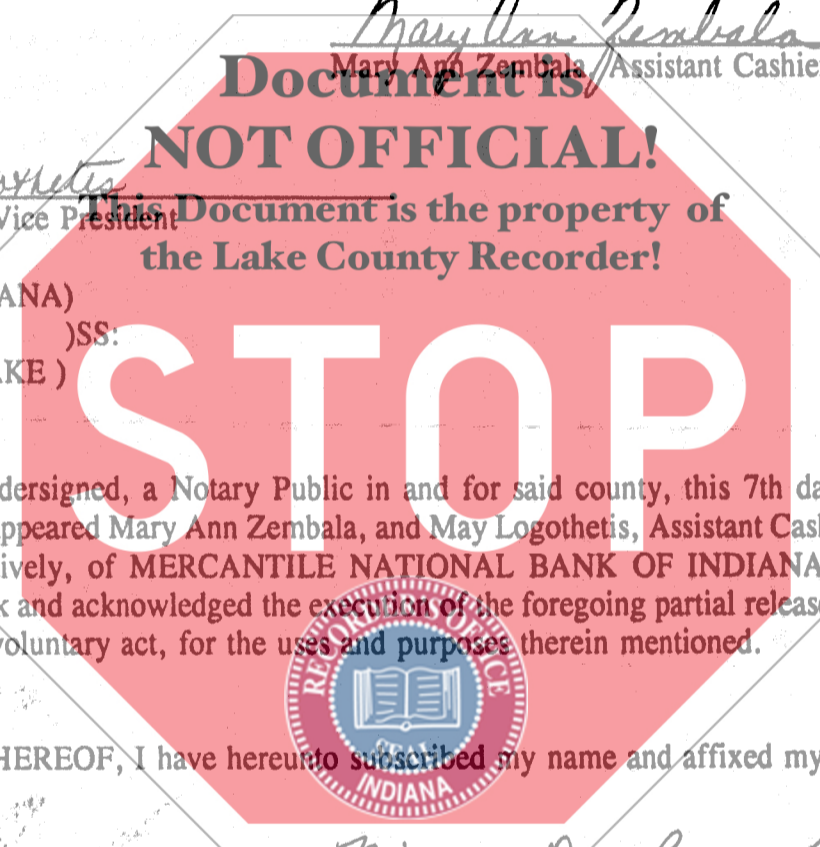

LEGAL DESCRIPTION

Part of Tract 21 in Pebble Brooks, Phase Three, a Planned Unit Development, in the City of Crown Point, as per plat thereof, recorded in Plat Book 74 page 25, in the Office of the Recorder of Lake County, Indiana, and amended by a Certificate of Correction recorded June 7, 1994 as Document No. 94042337, described as follows: Commencing at the Northwest corner of said Tract 21; thence South 19 degrees 35 minutes 17 seconds East along the Westerly line of Tract 21, a distance of 74.33 feet to the point of beginning; thence North 70 degrees 24 minutes 43 seconds East, parallel with the Northerly line of said Tract 21, a distance of 91.88 feet to the Easterly line of said Tract 21; thence South 24 degrees 45 minutes 40 seconds East along said Easterly line a distance of 21.89 feet to a point of curve; thence Southerly along a curve concave to the Northeast and having a radius of 58.00 feet, an arc distance of 3.98 feet; thence South 70 degrees 24 minutes 43 seconds West, parallel with the Northerly line of Tract 21, a distance of 94.45 feet to the Westerly line of said Tract 21; thence North 19 degrees 35 minutes 17 seconds West along said Westerly line, a distance of 25.75 feet to the point of beginning.
