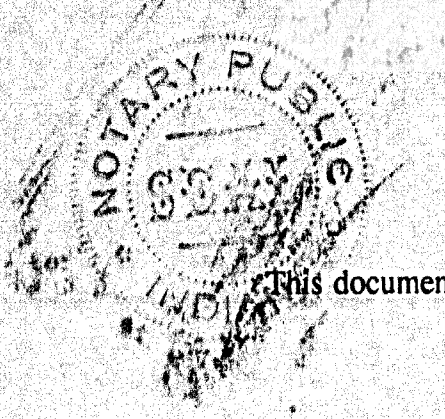

LEGAL DESCRIPTION

Part of Tract 21 in Phase Three of Pebble Brooks, a Planned Unit Development in Crown Point, Indiana, as shown in Plat Book 074, page 25 in the Office of the Recorder of Lake County, Indiana, which part of said Tract 21 is described as follows: Beginning at the Northwest corner of said Tract 21; thence North 70 degrees 24 minutes 43 seconds East, along the Northerly line of said Tract 21, a distance of 82.49 feet; thence South 73 degrees 39 minutes 10 seconds East, a distance of 22.63 feet to a point on the curved Easterly line of said Tract 21; thence Southerly along a curve concave to the East, and having a radius of 58.00 feet, an arc distance of 35.31 feet; thence South 70 degrees 24 minutes 43 seconds West, parallel with the Northerly line of said Tract 21, a distance of 89.78 feet, to a point on the Westerly line of said Tract 21; thence North 19 degrees 35 minutes 17 seconds West along the last described line, a distance of 46.25 feet to the point of beginning.
