Mortgagor will pay the indebtedness as hereinbefore provided including paying any deficiency hereunder without relief from valuation and appraisement laws, keep the improvements on the property insured against loss or damage by fire and such other risks customarily covered by fire and extended coverage insurance in amounts as hay be required from time to time by Mortgagea and procured from an insurance company chosen by Mortgagor and acceptable to Mortgagee, observe and porform all covenants, terms and conditions of any prior mortgage or any lease if this mortgage is an a leasehold; keep the Mortgaged Premises in good repair; promptly pay all texes, assessments, and legal charges against said property, insurance premiums, installments of principal and interest on any prior mortgage, and, to the extent permitted by law, reasonable attorney's fees and court costs which actuality are expended in the enforcement of defense of this mortgage or any other instrument securing this loan, and in the event of default in any payment the Mortgagoe may pay the same and the Mortgagor shall repay to the Mortgagee the amount so paid together with interest at the highest rate provided for in the pote secured hereby not to exceed the highest amount permitted by law, and all sums so paid will be secured by this mortgage, no improvements shall be removed or destroyed without the written consent of the Mortgagoe; the Mortgagoe shall be entitled to the appointment of a receiver in any action to forceous upon default being made in the payment of any of the intallements hereofore specified on the due date thereof, or upon default in any of the terms, covenants or conditions of the mortgagoe and beauty as a payment may be enforced by the foreclosure of the mortgage and action of the Mortgagoe. All such policies of insurance and all abstracts of title or title insurance policies covering the Mortgaged Premises shall, at Mortgagee's request, be delivered to and retained by Mortgagee until the indebtedness secured hereby is fully paid.

Any forbearance by Mortgagee in exercising any right or remedy hereunder, under the note or otherwise afforded by applicable law, shall not be a waiver of or preclude the subsequent exercise of any such right or remedy. The procurement of insurance or the payment of taxes or other liens or charges by Mortgagee shall not be a waiver of Mortgagee's right to accelerate the maturity of the indebtedness secured by this Mortgage.

All remedies provided in this Mortgage are distinct and cumulative to any other right or remedy under this Mortgage or afforded by law or equity, and may be exercised concurrently, independently or successively.

Mortgagor includes each person executing this instrument if more than one, his heirs, successors and assigns and Mortgagee includes its successors, assigns and attorneys.
