AFFIDAVIT

VICTORIA E. KUEHL, being first duly sworn upon her oath, states:

1. That her father, Alfred P. Torrenaga, did own a one-half (1/2) undivided interest in the following described real estate:

2. That the affiant also owned the remaining one-half (1/2) interest in the above-described property.

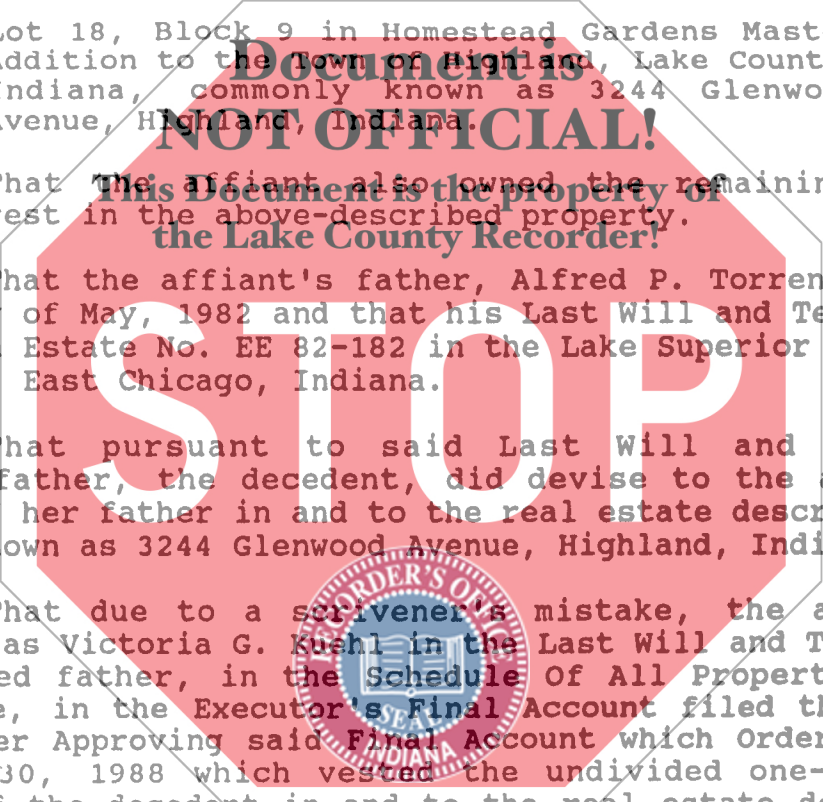

6. That the affiant's true and correct name is Victoria E. Kuehl and not Victoria G. Kuehl and that the person referred to as Victoria G. Kuehl in said estate proceedings is in fact Victoria E. Kuehl as the decedent, Alfred P. Torrenaga, had no other daughter.

7. That the affiant has also been known as Victoria E. Roehrich which was her name prior to her divorce and in said divorce her name was restored to Victoria E. Kuehl.

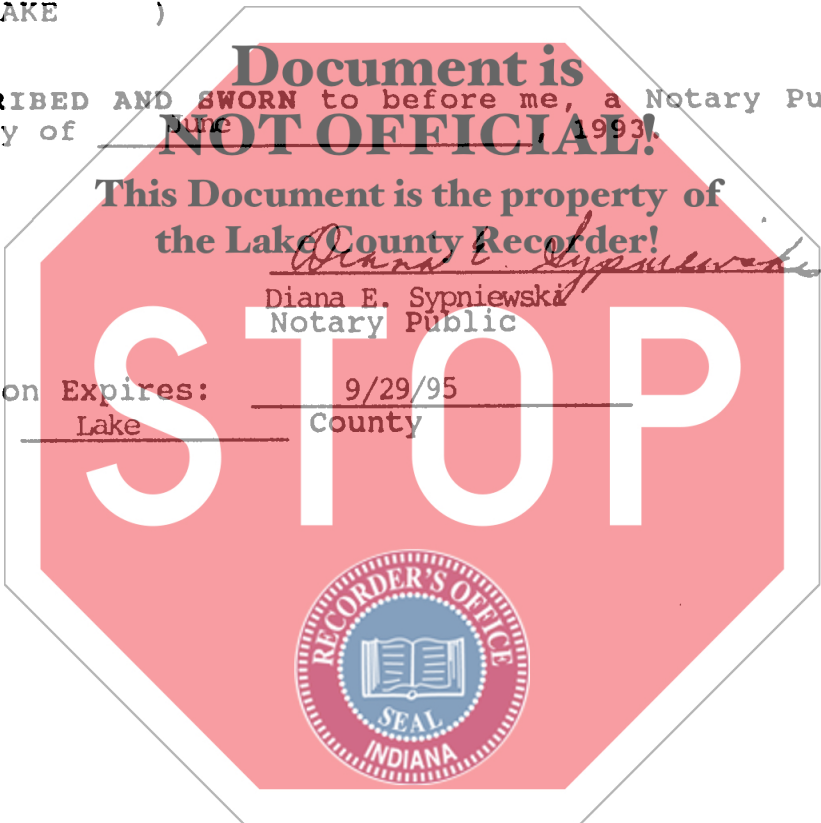
