AND, WHEREAS, the County Auditor did on the 26th day of September, 19 95 report his proceedings therein to the Board of Commissioners.

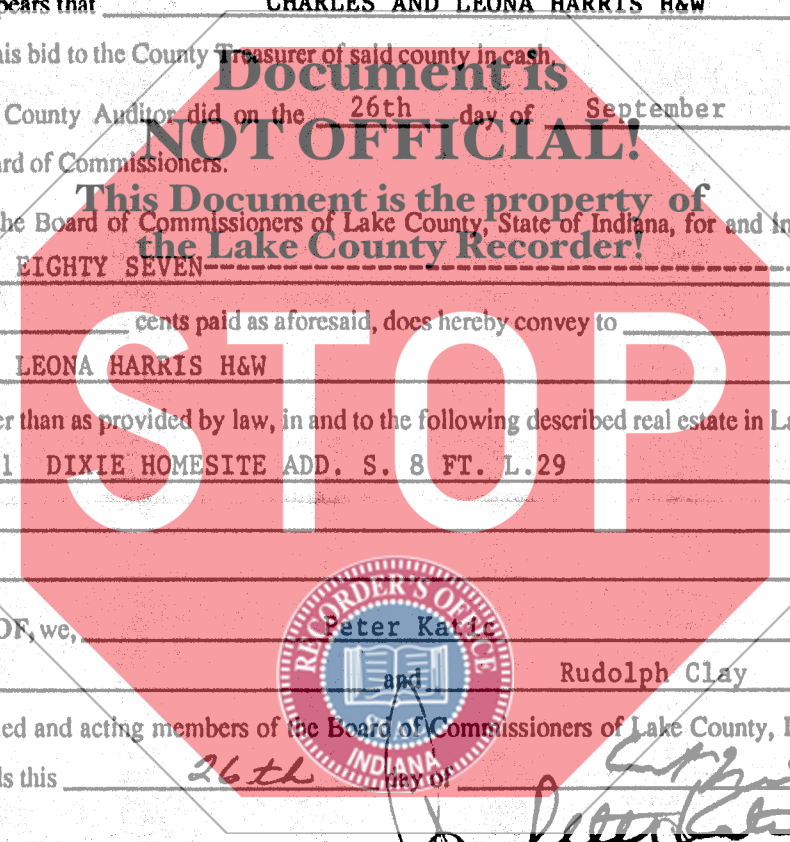
