And it appearing that no objections were filed therete and the Court pring fully advised in the premises, now finds that AND

- Due notices of the filing of said account and petition and of the hearing on 1. the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.
- That Olga B. Josipovic f/k/a Olga B. Djordjevic, died intestate, a resident 2. of the County of Lake, State of Indiana, on the 19th day of December, 1994, and this

Court appointed said Maria Djordjevic as Personal Representative of the Estate of Olga B. Josipovic f/k/a Olga B. Djordjevic, Deceased, and said Personal Representative was issued Letters Testamentary on the 3rd day of January, 1995, and since that date she has continued to serve in such capacity.

- 3. That the matters and things stated in said account and petition are true and that said Personal Representative has accounted for all of the assets in this estate coming into her hands.
- 4. More than five 5 months have since the date of the first published notice to the helps and creditors of said decedent, all claims filed against said estate have been paid and discharged; neither said decedent nor her Personal the Lake County Recorder!
