2. All easements, restrictions and covenants of record, if any.

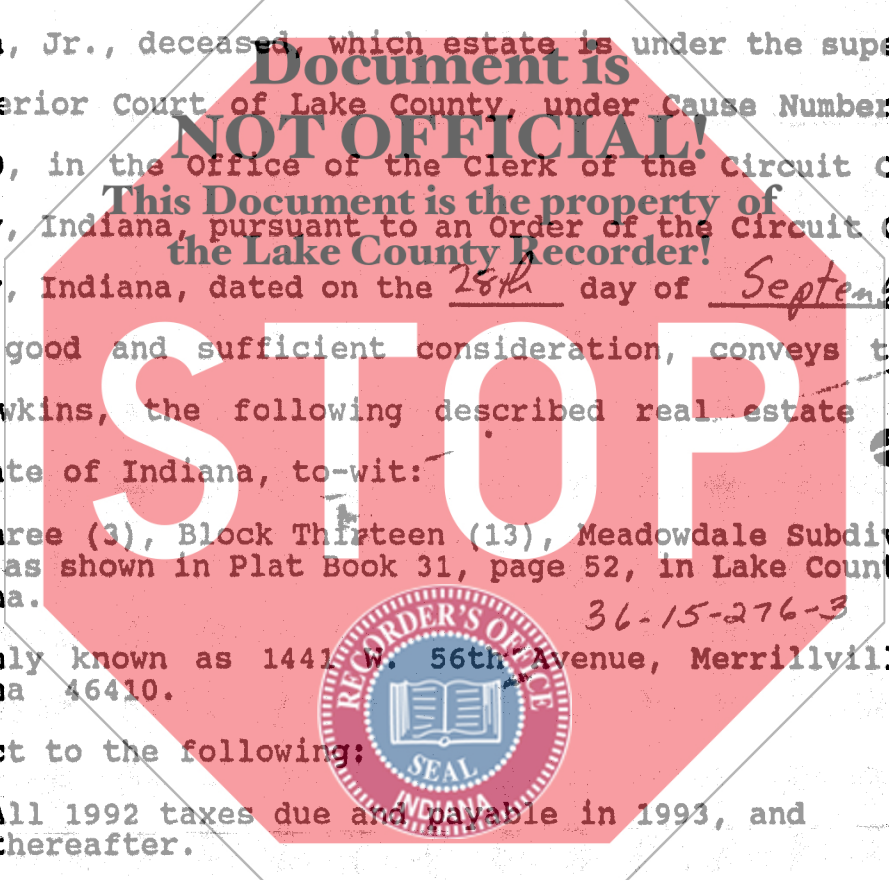

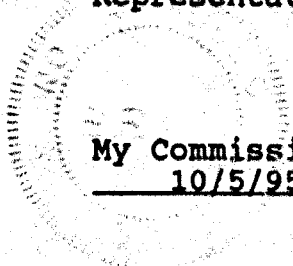

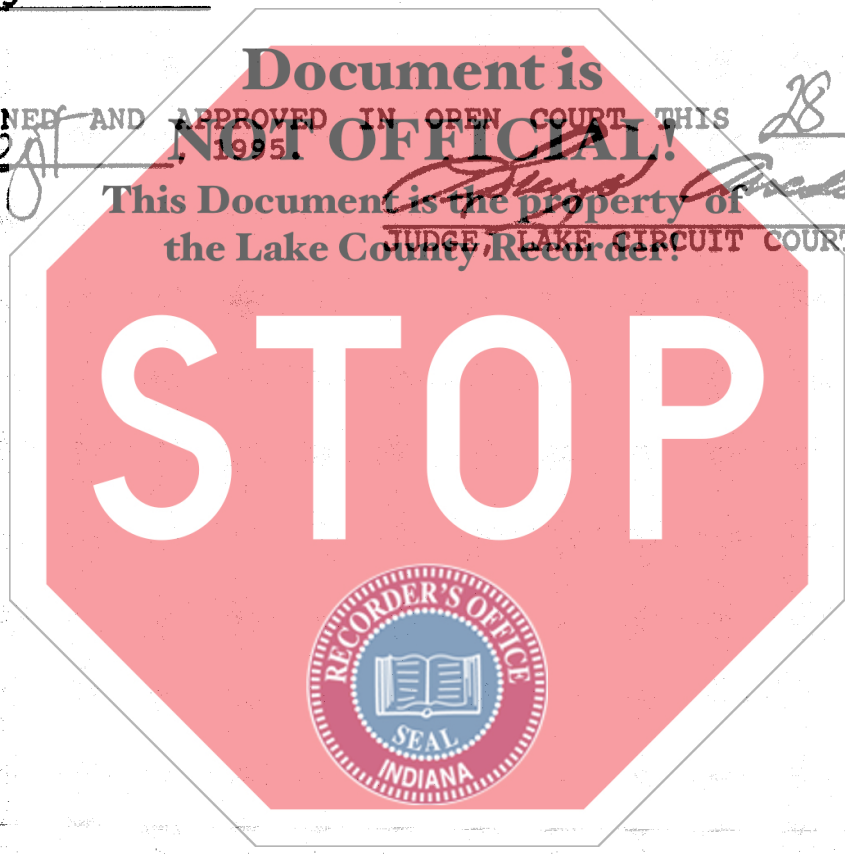
