

RIDER - LEGAL DESCRIPTION

LOT 22 (EXCEPT THE SOUTH 10 FEET THEREOF), FAIRVIEW ADDITION TO MUNSTER, AS SHOWN IN PLAT BOOK 25, PAGE 61, IN LAKE COUNTY, INDIANA, ALSO A PARCEL OF LAND IN THE NORTHWEST FRACTIONAL QUARTER OF SECTION 19, TOWNSHIP 36 NORTH, RANGE 9 WEST OF THE 2ND PRINCIPAL MERIDIAN, MORE PARTICULARLY DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHWEST CORNER OF LOT 22 FAIRVIEW ADDITION TO MUNSTER, IN LAKE COUNTY, INDIANA, AND RUNNING THENCE EAST ALONG THE NORTH LINE OF SAID LOT 22 TO THE NORTHEAST CORNER OF SAID LOT 22; THENCE NORTH ALONG THE EAST LINE OF SAID LOT 22 EXTENDED NORTH A DISTANCE OF 20 FEET TO A POINT; THENCE WEST PARALLEL TO THE NORTH LINE OF SAID LOT 22 TO THE EAST LINE OF HOWARD AVENUE; THENCE SOUTH ALONG THE EAST LINE OF HOWARD AVENUE A DISTANCE OF 20 FEET TO THE PLACE OF BEGINNING, ALL IN THE TOWN OF MUNSTER, IN LAKE COUNTY, INDIANA.
